RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS RECOGNIZING LISA COLCLEASER, ACCOUNTING CLERK III, UPON HER RETIREMENT FROM THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES, WELFARE ADMINISTRATION DIVISION, FISCAL DISBURSEMENT BUREAU, WITH 31 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY

WHEREAS, Lisa Colcleaser began her 31-year career in public service on August 15, 1993 as a Records Clerk in the Department of Health and Social Services, Eligibility Services' Records unit located on the H&SS Vallejo campus; and

WHEREAS, in April 1997, Ms. Colcleaser promoted to a Clerical Support Specialist, where she updated benefit assistance eligibility in the statewide Medi-Cal Eligibility Data System (MEDS), issued Benefits Identification Cards and immediate need benefits cards for Supplemental Security Income clients; and

WHEREAS, in August 1999, Ms. Colcleaser promoted to an Accounting Clerk II in Welfare Administration's Fiscal Disbursement Unit, which later became the Fiscal Disbursement Bureau, where she processed benefit assistance payments to CalWORKs, CalFresh, General Assistance, and Welfare-to-Work clients; and

WHEREAS, in 2011, after completing coursework in principles of accounting, Ms. Colcleaser promoted to an Accounting Clerk III where she reconciled daily and monthly reports of fiscal benefit payment issuances; and

WHEREAS, throughout her career, Ms. Colcleaser was a valuable, hardworking, dedicated, kind, patient, and trustworthy employee who went above and beyond for clients; and

WHEREAS, Lisa Colcleaser will be missed by her friends and coworkers in the Fiscal Disbursement Bureau for her dedication to serving the needs of Solano County clients, her positive outlook and energy, her willingness to help, and the warmth that she gives to the people around her.
