**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS  
RECOGNIZING JANELLE BOGUE, OFFICE SUPERVISOR, UPON HER RETIREMENT  
FROM THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES,  
WELFARE ADMINISTRATION DIVISION, FISCAL ISSUANCE UNIT,  
WITH 23 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY**

**WHEREAS**, Janelle Bogue began her 23-year career in public service on May 2, 2001, as an Office Assistant II in the Department of Health and Social Services, Welfare Administration Division, Fiscal Issuance Unit; and

**WHEREAS**, on February 17, 2002, Ms. Bogue transferred to the Auditor Controller's Office as an Accounting Clerk I, where she performed clerical and statistical record keeping tasks; and

**WHEREAS**, on September 15, 2002, Ms. Bogue promoted to Accounting Clerk II, and on January 30, 2005, she promoted to Accounting Clerk III where she provided accounting support, auditing vendor claims, journals, deposit permits and encumbrances, post-financial transactions, and tracking of statistical information; and

**WHEREAS**, on December 30, 2007, Ms. Bogue promoted to an Accounting Technician in Health and Social Services, Administration Division, where she provided accounting support and statistical reporting and recording activities; and

**WHEREAS**, Ms. Bogue transferred on September 24, 2017, to the Fiscal and Reporting Unit in Employment and Eligibility Services, and promoted to Office Supervisor on November 1, 2020, where she supervised a team and was responsible for financial and statistical programmatic reporting, and provided support during the migration to the California Statewide Automated Welfare System (CalSAWS) project; and

**WHEREAS**, on March 31, 2024, Ms. Bogue transferred to the Welfare Administration Division where she supervised a team in Supportive Services Issuances which supports individuals in becoming self-sufficient; and

**WHEREAS**, Ms. Bogue performed her duties with professionalism, hard work, commitment to the County's service, and dedication to her community and those in need.
