**RESOLUTION OF THE BOARD OF SUPERVISORS OF SOLANO COUNTY  
DESIGNATING ADVENTIST HEALTH VALLEJO AS A WELFARE AND INSTITUTIONS  
CODE §§ 5150 et seq. and §§ 5585.50 et. seq. INVOLUNTARY DETENTION FACILITY**

**WHEREAS**, Welfare and Institutions Code §§ 5150 et seq. and §§ 5585.50 et. seq. authorizes the County of Solano to designate facilities as evaluation and treatment facilities under the above-referenced code sections and professional persons to take or cause to be taken certain mentally disordered adults, children, and adolescents into custody; and

**WHEREAS**, Adventist Health Vallejo is an acute psychiatric hospital located at 525 Oregon Street, Vallejo CA 94590, and meets the requirements to be designated as an evaluation and treatment facility pursuant to Welfare and Institutions Code §§ 5150 et seq. and §§ 5585.50 et. seq.; and

**WHEREAS**, individuals can be placed in Adventist Health Vallejo under Welfare and Institutions Code §§ 5150 et seq. and §§ 5585.50 et. seq.; and

**WHEREAS**, the Medical Director at Adventist Health Vallejo and its staff are appropriate mental health professionals to make determinations under §§ 5150 et seq. and §§ 5585.50 et. seq.

**NOW, THEREFORE BE IT RESOLVED**, that Adventist Health Vallejo and its mental health staff professionals are designated by the County as specified in §§ 5150 et seq. and §§ 5585.50 et. seq. of the Welfare and Institutions Code of the State of California, subject to the following conditions:

1. That the Medical Director of the designated facility submit a list of such authorized professional persons on an annual basis to the Behavioral Health Director; and
2. That such individuals have completed a 5150 et seq. training course, approved by the Behavioral Health Director, every two (2) years or in accordance with current County Policy; and
3. That this designation to detain persons is applicable 24 hours per day and 7 days a week at Adventist Health Vallejo; and
4. That Adventist Health Vallejo shall retain responsibility for providing such care as is medically and clinically appropriate, consistent with its policies and health plan contracts; and
5. That the designated facility operations will be consistent with all relevant statutes, codes, and regulations; and
6. That this designation is contingent upon triennial (every three years) review and approval by the Behavioral Health Director.
