As a constituent Division with a budget of approximately \$72,000,000, we operate both the Substance Use Disorder and Mental Health Programs under contract with the State Department of Health Care Services.

We have a history of strong interest in care coordination, bi-directional integrated care, and excellent collaboration with other agencies and our own sister Divisions. Both our primary care and specialty psychiatry clinics feature behavioral medicine/integrated primary care; and our Divisions (Health Services and Behavioral Health) recently completed a year-long Integrated Care Learning Collaborative with California Institute of Behavioral Health Services.

As a mid-size county, we have excellent working relationships with our sister Divisions and feature a number of collaborative projects that benefit from our close colocation, common management structure, and identity as a Super-Agency.

Behavioral Health is very pleased and excited to be one of the lead partners in this project and believe that the pilot will enable our community to take a further step in the direction of the Triple Aim and value-based care.

Behavioral Health is fully committed to prioritizing service access to clients identified in the pilot for psychiatric and substance abuse services, and in addition to covering its responsibilities under Medi-cal, will be offering in-kind resources to this project such as a SUD engagement specialist, quality assurance support and strong leadership to ensure this project achieves its commendable aims.

Currently, the Behavioral Health Division is undertaking a cultural transformation program that will last 5 years with Professor Sergio Aguilar at the University of California at Davis, Center for Health Disparities.

We believe that with the opportunities that O.D.S. presents, our history of active work toward reducing silo's, creation of an HIE (in progress), integrating care (SUD and MH both), we are well poised to assist the Department as the Lead Agency in this pilot.

It is my pleasure to add NorthBay Healthcare's support of the Whole Person Care Pilot being submitted to DHCS by Solano County Health and Social Services.

NorthBay Healthcare is an independent, community-based, nonprofit, two-hospital system serving Solano County with acute hospital care services for residents and non-residents of the county. The 132-bed NorthBay Medical Center in Fairfield includes a Level 2 trauma center. NorthBay VacaValley Hospital in Vacaville is a community hospital with a 50-bed capacity.

NorthBay Medical Center is uniquely positioned as the only acute-care hospital in the central county. Compassionate care is extended to all, regardless of their ability to pay, distinguishing NorthBay from other providers in a county without a taxpayer-supported hospital.

NorthBay Healthcare has a long history of partnering with Solano County's Health and Social Services (SCHSS) department to provide key health services. We are a founding and current partner with the county's Transitional Care Program (TCP), providing respite housing for the homeless recently discharged from our hospital. The program required years of collaboration with the SCHSS before the program came to fruition four years ago.

Currently there are two TCP houses in the county that provide short-term residential services for many who otherwise would be discharged to the streets. This successful program is an excellent example of how hospital systems and counties can work together to serve those in need of help with shelter, food, case management, mental health and substance abuse services and support.

Additionally, NorthBay Healthcare continues to participate in the Solano County Mental Health sponsored monthly Psychiatric Emergency Services (PES) meetings. Other participants include other hospitals and prison system participants along with local law enforcement. These meetings provide a platform for sharing information that facilitates care process and program improvement.

With mental health problems growing and contributing to issues involving law enforcement, crisis

psychiatric care services and very often hospitalization, the PES meetings are invaluable. PES participants discuss challenges and opportunities for program and process improvement.

NorthBay Healthcare's senior management also participates in Solano Coalition for Better Health's meetings focusing on the adequacy of Primary Care Physicians and Behavioral Health service access for our community patients. Key community stakeholders also attend these meetings addressing service gaps and possible solutions.

The Whole Person Care Stakeholder (WPCS) program proposal as presented by Solano County Health and Social Services could provide some residential and outpatient case management coordination of care services and support for a very challenging population. In our emergency rooms and hospitals, we encounter many patients who would benefit from this WPCS program.

Many patients, who for various reasons (i.e., sex offenders, substance abusers, handicapped), are not able to access health care services and may become homeless. Not only will this program provide some respite living arrangements for some of these patients, but also provide for follow-up case management interventions to assist these patients with accessing much needed community resources to potentially prevent further issues.

It should be a "win-win" for NorthBay Healthcare, the county and these patients! NorthBay Healthcare and the county will win by meeting the needs of our patients with outpatient coordination of care services, support and housing assistance, and ultimately, by providing much-needed environmental stability and support. The winning outcome of this pilot will be an increase in preventive and primary care visits and a reduction in costly, unnecessary hospital emergency room visits and hospital admissions.

NorthBay Healthcare has emergency room case managers, outpatient complex case managers and hospital social workers who could assist with identifying appropriate patients for the Whole Person Stakeholder program. We are eager to work with the county and identify WPCS program contacts to assist these patients in accessing resources to improve their quality of life. We can also share appropriate data relative to patient identification and outcomes.

In conclusion, I fully support the efforts of the Solano County Health & Social Services department as they seek funding to support a Whole Person Care pilot designed to improve health care outcomes, care and supports for the most vulnerable people in the county.

Housing First Solano (HFS), the Vallejo-Solano County Continuum of Care, supports Solano County Health and Social Services (SCHSS) in the Whole Person Care Pilot being submitted to DHCS.

HFS is dedicated to creating and maintaining a system of care to end homelessness in Solano County. Increased integration between health, behavioral health, and homeless services, particularly among the hardest to serve, is vital to this effort. According to Solano County's 2015 Point-In-Time Count, thirty-two percent (32%) of people experiencing homelessness reported that they have psychiatric or mental health conditions, but only thirteen percent (13%) reported using mental health services. Forty-six percent (46%) reported drug and alcohol abuse, while only nine percent (9%) reported utilizing drug and alcohol counseling services. Facilitating these connections and creating new resources for those who need additional help are critical steps in helping frequent systems users obtain and maintain housing and improve their health outcomes.

SCHSS is an active member of HFS and is well-positioned to lead the Whole Person Care effort in Solano County. They work closely with other providers throughout the County and have been active in HFS's efforts to improve coordination with healthcare, create plans for jail and prison discharge, and increase use of data for system performance measurement and coordination.

In conclusion, HFS supports the efforts of SCHSS in their application for the Whole Person Care pilot designed to improve health care outcomes, care and supports for the most vulnerable people in the county.

Bay Area Community Services has a long history of focused work with the severely mentally ill consumer and cooccurring populations in the Bay Area. We are very excited to be able to lend our support to this exciting project.

Among the projects we operate are supported housing arrangements offering a range of mental health and substance abuse services to individuals within a 7-story building in downtown Oakland, Ca. We have found the model of supported housing to be especially powerful as a core element of recovery, and consistent with the HUD's Housing First model. We also offer Crisis Stabilization, Peer Respite and Crisis Aftercare services within Solano County and provide critical services to its seriously mentally ill and co-occurring population.

We are in the process of renovating 7 2-bedroom units for Solano County in Fairfield at 345 Travis Boulevard, using unspent CalHFA MHSA Housing funds provided by the County, and can commit to providing up to 10 beds for the purposes of this project under this agreement. With our on-site peer respite program, and support by the County to provide on-site housing support, we are in an excellent position to help Solano and its partner applicant, Solano Coalition for Better Health, rapidly house enrollees in their Pilot TCP+ program while they are stabilized, and assist in locating more permanent housing. Using a Harm-Reduction model, we do not stipulate full sobriety or recovery from drug and alcohol abuse except when it would threaten the overall operation of the supported housing; this program philosophy is also reflected in our other services and allows us to ensure individuals stay housed as a precondition of their recovery, not recovered as a precondition of their housing. This model is extremely successful with the complex medical-behavioral needs of the individuals that will benefit from this program.

We understand the County will be exploring additional housing stock and supports as the needs of its target population are better understood and look forward to helping in any way we can.

I fully support the efforts of the Solano County Health & Social Services department as they seek external funding to support a Whole Person Care pilot designed to improve care and health care outcomes, and improve supports for the most vulnerable people in our community.

SCSAS provides services to Medi-Cal eligible individuals seeking to recover from substance abuse through services funded by SAPT-BG federal funds and Drug Medi-Cal, under contract with the State. We have worked as an integral service provider under the general Health and Social Service Umbrella with most of our fellow Divisions and other County Departments, including Mental Health, Physical Health, Child Welfare, the Courts, and others. We are very excited that the Department is working with the Coalition to apply for funds to provide a comprehensive Whole Person Care pilot, and have experience providing integrated substance abuse services in the recent past. It is my pleasure to write a letter to discuss the Solano County Sheriff's Office support of Solano County Health and Social Services in the Whole Person Care pilot being submitted to DHCS.

The Sheriff's Office has a long history of working collaboratively with Health and Social Services on behalf of transitioning individuals with medical, mental health and substance use disorders to the community. We have an embedded H&SS Mental Health Provider within the jail to assist in the transition of individuals from jail to community. Jail healthcare providers and H&SS cooperatively care for individuals enrolled in H&SS chronic care clinics. In 2015, the Sheriff's Office and Health and Social Services partnered to develop and win a grant focused on a county-wide approach to recidivism reduction for mentally ill offenders. This grant has allowed for the development and leverage of resources from various county departments in support of reducing incarceration and jail time for the mentally ill.

The Sheriff's Office staff serves with H&SS on multiple committees and projects that assist each agency in the identification of needs within our communities. Currently, the Sheriff's Office participates in Solano County Local Public Health System Assessment and serves on the H&SS Criminal Justice Workgroup, which is focused on the Affordable Care Act at this time. Additionally, we participate in the Psychiatric Emergency Services Committee. The PES reviews systemic service needs for our mental health population. Community law enforcement agencies and community providers meet monthly to review the issues, and individual consumers are discussed post-meeting to identify specific areas of improvement.

In conclusion, I fully support the efforts of Solano County Health & Social Services department as they seek external funding to support a Whole Person Care pilot designed to improve healthcare outcomes, care and supports for the most vulnerable people in the county. 
