

# Resolution No. 2025-145

## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING MEGAN M. GREVE, DIRECTOR OF GENERAL SERVICES, UPON HER RETIREMENT WITH 19 YEARS OF DISTINGUISHED PUBLIC SERVICE, INCLUDING 7 YEARS OF SERVICE TO SOLANO COUNTY

**WHEREAS**, Megan M. Greve began her employment with the Solano County General Services as the Director of General Services on August 27, 2018, consistently exemplifying unwavering dedication to public service, characterized by excellence, integrity, and innovation; and

**WHEREAS**, Ms. Greve has contributed 19 years of dedicated public service, beginning in 2006 as a Management Analyst-Project Manager for the City of Lathrop. She went on to serve as a Senior Analyst with the Sutter County Administrator's Office in 2010, was promoted to Deputy County Administrator in 2012 and in recognition of her exceptional services, Ms. Greve became Sutter County's first General Services Director in 2013; and

**WHEREAS**, Ms. Greve joined Solano County in 2018 as the Director of General Services, where she has overseen a diverse and vital portfolio, including Administrative Services - Support Services (Fiscal and Administrative Support, Purchasing, Mail Services, Surplus, Records Management), Capital Projects Management (including Real Estate Services), Facilities Maintenance (Operations, Grounds Maintenance, Custodial Services), Fleet Management, Nut Tree Airport, and the creation of a new Energy and Utilities Division; and

**WHEREAS**, Ms. Greve holds a Bachelor of Science in Animal Science from the University of California, Davis and a Master of Business Administration from Northern Arizona University. Ms. Greve is a Credentialed California County Senior Executive through the California State Association of Counties (CSAC) Institute and has been recognized as both a CSAC Fellow and a Mentor; and

**WHEREAS**, Ms. Greve has demonstrated a strong commitment to professional development and knowledge-sharing through active involvement in professional networks. She served as Director of Finance for the Women in Project Management Special Interest Group. Ms. Greve currently serves as Treasurer on the Board of Directors for the California General Services Administration. Ms. Greve earned the prestigious Achievement of Excellence in Procurement (AEP) award from the National Procurement Institute for outstanding leadership, innovation, advancement in procurement; and

**WHEREAS**, Ms. Greve has been a visionary leader, implementing innovative and sustainable programs and services, including leading the \$53 million Countywide Energy Conservation and Resilience Project, installing solar photovoltaic systems across multiple campuses to enhance energy resilience and ensure service continuity during Public Safety Power Shutoffs and other outages, and transitioning the County's diesel fleet to RD999 renewable diesel to significantly reduce carbon emissions and environmental impact. She also supported the passage of Assembly Bill 1957 (Wilson), expanding best-value contracting under Public Contract Code (PCC) §20155 to all California counties, improving contractor quality over traditional low-bid practices; and

**WHEREAS**, Ms. Greve led her team through multiple disaster recovery efforts, including the response to the LNU Lightning Complex Fire, which involved emergency repairs, construction of new public safety communications infrastructure, and the establishment of a Local Assistance Center (LAC) to support affected residents. Ms. Greve also ensured operational continuity during the COVID-19 pandemic by addressing supply chain disruptions, managing construction delays, and implementing safety protocols for County staff; and

**WHEREAS**, Ms. Greve has overseen significant infrastructure and capital projects, including the construction of the \$14.5 million Solano Residential Mental Health Diversion and Adult Board and Care Facilities in Fairfield, creating new 32-bed licensed residential facilities, and secured \$20 million in federal funding through FEMA Hazard Mitigation Grant Program for the Justice Campus Asset Protection Project, including upgraded stormwater facilities, security features, and improved pedestrian infrastructure; and

**NOW, THEREFORE BE IT RESOLVED**, that the Solano County Board of Supervisors hereby honors and recognizes Megan M. Greve for her 19 years of exceptional public service, including seven years of dedicated service to the citizens of Solano County, and extends its deepest appreciation and best wishes for continued success, and heartfelt congratulations on her well-deserved retirement.
