Program Services Manager Renee Smith provided an overview of the CalAIM Justice-Involved Initiative program.

In response to a question from Supervisor Brown regarding what it means to "draw down" MediCal, Ms. Smith stated to "draw down" MediCal means to bill for services and receive funding for those services provided by the jail which is something the jail has never been able to do before.

In response to a question from Supervisor Williams regarding the lack of funding under reentry planning and coordination, Ms. Smith stated there was no need for funding in this section because this work is already being completed by in-house providers whose work will be shifted to this grant.

Chair Mashburn thanked staff for their work on obtaining the grant funding, and commented in support of the program, noting it is the first time the County will be able to utilize MediCal funding for services provided in the jail.

Supervisor Vasquez commented in support of the program, noting it will help improve the lives and health of those individuals who are in the system.

*Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.*

In response to a question from Supervisor Williams regarding a staffing shortage at the Housing Authority, Ms. Aguilar-Vasquez stated the Housing Authority has recently hired one housing technician, and is in the process of opening a second recruitment for an additional housing technician.

Chief Deputy Clerk of the Board Alicia Draves introduced the item and provided a brief overview of the City Selection Committee nomination process for the Solano County representative to the Metropolitan Transportation Commission (MTC).

In response to a question from Supervisor Brown regarding the potential conflict of appointing a member from the City of Benicia, County Counsel Bernadette Curry stated the Solano County Transit (SolTrans) Joint Powers Authority is made up of two members from the City of Vallejo and two members from the City of Benicia, as well as the MTC representative. Ms. Curry further stated that in order to avoid over-representation for either city, if the appointed MTC representative is a city council member from either city or a supervisor who represents either city, then the MTC representative is appointed by the Solano Transportation Authority Board.

In response to a question from Supervisor Williams regarding posting requirements for vacancy notices and posting on the Solano County website, Ms. Draves stated all vacancy notices for the Board of Supervisors are posted per the Maddy Act on the County's website, under the Board of



Supervisors' Boards and Commissions page. Ms. Draves further stated, this particular vacancy is not a vacancy of the Board of Supervisors, but is a vacancy for the Solano County City Selection Committee; therefore, the vacancy notice was posted on the City Selection Committee's webpage which can be found on the Solano County website.

In response to a question from Supervisor Vasquez regarding Maddy Act requirements, Ms. Draves stated the Maddy Act is a portion of the Government Code that pertains directly to the posting of vacancy notices to ensure the appointment process is transparent. Ms. Draves further stated vacancy notices are posted individually online and as a list in the lobby window of the county administration center. Ms. Draves further stated there is an additional list posted both in the lobby window of the county administration center and at the County's libraries that contains all expected upcoming vacancies for the following year that are as a result of a term ending.

*Chair Mashburn invited members of the public to address the Board on this matter and the following comments were received:*

*A) City of Suisun City Mayor Alma Hernandez commented on the City Selection Committee process of selecting individuals for the recommendation, noting that there was discussion and a motion made to delay the vote; however, it was defeated. Planning Program Manager Allan Calder introduced the item.

In response to a question from Supervisor Brown regarding FEMA funding to mitigate the potential of a landslide on Lopes Road, Mr. Walsh stated if the update for the Public Health and Safety is approved, a resolution will be executed, which will make the County competitive for future grants, although he can't specify if it will be a FEMA grant in particular.

Consultant Eli Krispi provided an overview of the work completed on the General Plan Public Health and Safety Chapter update.

In response to a question from Supervisor Vasquez regarding how to look at the enhanced focus on wildland-urban interface area and coordinating with the cities that have open spaces next to unincorporated areas of Solano County, Mr. Krispi stated this is a multi-jurisdictional program even though this chapter in particular only deals with the unincorporated areas. Mr. Krispi further stated this update is part of a larger program where the cities and the County work together to update their Housing Elements and Safety Elements at the same time to ensure all are looking at the same issues.

In response to comments from Supervisor Brown regarding FEMA, Mr. Bezek, stated this Health and Safety Plan update qualifies the County for FEMA disaster relief funds which are prioritized for communities that have an updated hazard mitigation plan. Mr. Bezek further stated this update also qualifies the County for California Disaster Assistance Act funds, which covers both repair and replacement of lost infrastructure and improvements as well as providing funding for hazard mitigation activities.

Supervisor Brown stated she has concerns regarding exits routes in the case of a natural disaster within her district. Supervisor Brown further stated she also has concerns regarding fire safety issues within her district. Supervisor Brown stated the County needs additional funding for these type of hazard mitigation needs.

In response to Supervisor Brown's comments, Mr. Calder stated the best practice for implementation of these types of policies would be to tie them to Capital Improvement Plan spending.

A discussion period was held.

*Chair Mashburn opened and closed the public hearing with no comments from the public.*

Supervisor Vasquez commented on the need for additional funding to provide for infrastructure improvements for both the County and the cities for potential damages as a result of climate change.



A discussion period was held regarding potential tax uses.

In response to a question from Supervisor Williams regarding the implementation of the plan being tied to the Capital Improvement Plan, Mr. Calder stated implementation could be tied to the Capital Improvement Plan and/or the Planning Work Plan so that decisions over the next years would relate to the General Plan. Mr. Calder further stated staff is also evaluating the creation of an implementation workbook, which is a summary document of the General Plan, so that when decisions are made, they can relate directly back to the General Plan.

Supervisor Williams commented in support of Mr. Calder's comments.
