**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS  
AUTHORIZING THE APPOINTMENT OF JESSICA ABBOTT AS A PUBLIC SAFETY DISPATCHER  
(SENIOR) AND AUTHORIZES THIS EMPLOYEE TO EXCEED THE STANDARD 960-HOUR CALPERS  
RETIRERD ANNUITANT LIMITATION PURSUANT TO SENATE BILL 1379 TO PROVIDE BACKFILL OF  
KEY ROLES TO ALLOW ACTIVE STAFF TO ASSIST VALLEJO WITH TEMPORARY LAW  
ENFORCEMENT SERVICES THROUGH DECEMBER 31, 2026**

**Whereas**, Senate Bill 1379 authorizes the Solano County Sheriff's Office to exceed the standard 960-hour limitation for retired annuitants performing duties regularly performed by deputy sheriffs, evidence technicians, or communications operators, provided the Board of Supervisors certifies compliance with statutory requirements by resolution adopted at a public meeting; and

**Whereas**, the Solano County Sheriff's Office seeks to appoint Jessica Abbott, CalPERS ID [REDACTED], as an extra-help retired annuitant in the classification of Public Safety Dispatcher (Senior) to perform duties regularly assigned to that classification in order to backfill key roles and allow active staff to assist the City of Vallejo with temporary law enforcement services, and has verified that the individual has successfully completed a pre-employment background investigation and is not subject to, nor under investigation for, decertification by the Commission on Peace Officer Standards and Training (POST); and

**Whereas**, the County of Solano conducted recruitment for the Public Safety Dispatcher (Senior) classification for a period of not less than six continuous months prior to this appointment, with no other qualified active applicants available for hire, and has established compensation for Jessica Abbott in compliance with Senate Bill 1379, such that the hourly rate does not exceed the average hourly rate for the classification nor the higher of the annuitant's final active rate of pay or the entry-level rate on the publicly available salary schedule; and

**Whereas**, the Solano County Sheriff's Office has confirmed that approval of this appointment does not cause the total number of retired annuitant appointments authorized under Senate Bill 1379 and related provisions of the Government Code to exceed the statutory maximum and that the County will remit the required monthly fee to CalPERS for this appointment.

**Resolved**, that the Solano County Board of Supervisors hereby certifies that the appointment of Jessica Abbott, CalPERS ID [REDACTED], as an extra-help Public Safety Dispatcher (Senior) meets all applicable requirements of Senate Bill 1379 and related provisions of the Government Code, approves the appointment, authorizes the individual to exceed the standard 960-hour CalPERS retired annuitant limitation, and authorizes the Sheriff's Office to implement the appointment through December 31, 2026, in compliance with all statutory, CalPERS, and administrative requirements.
