Deputy Director of First Five Denise Winters introduced the item and provided a brief history of the Community Investment Fund program.

Contracts and Program Manager Yuliana Moreno provided an overview of the FY2025/26 One-Time Investments for annual grants.

Supervisor Brown commented on the Request for Proposals process, and stated the panel reviewed everything, noting she wanted to ensure the needs of the constituents are met.

On motion of Supervisor Brown, seconded by Supervisor Williams, the Board:

Assistant County Administrator Debbie Vaughn introduced the item and provided a brief background on the Partnership HealthPlan Board of Commissioners, noting the Board has a total of three allocated positions on this commission which can be filled by four different representative types. Ms. Vaughn stated the representative types are Physician Representative, Hospital Representative, Director of Health and Human Services, and a Community Clinic Representative. Ms. Vaughn noted the current Director of Health and Social Services Emory Cowan was appointed to the Director of Health and Social Services Representative position in December of 2024, leaving three representative types and two vacancies to be filled. Ms. Vaughn further stated there are currently three applicants, two of which are for the Community Health Clinic Category, and one applicant that can fill either the Physician or Hospital Representative role.

In response to a question from Chair Mashburn regarding if he as the Chair can appoint two Supervisors to sit on an ad hoc interview committee, County Counsel Bernadette Curry stated yes he can.

Chair Mashburn asked for volunteers and Supervisors Brown and James stated they would be willing to serve.

Chair Mashburn appointed Supervisors Brown and James to the ad hoc committee to interview the two applicants for the Community Health Clinic category. Chair Mashburn opened the floor for a motion for the an appointment to the position of either Hospital Representative or Physician Representative.

On motion of Supervisor Vasquez, seconded by Supervisor Williams, the Board appointed Dr. Seth Kaufman, MD to the Partnership Health Plan Board of Commissioners as the Hospital Representative. So ordered by a 5-0 vote.

BOARD MEMBER COMMENTS AND REPORTS ON MEETINGS

Chair Mashburn invited members of the Board to make comments or reports on meetings. The following comments were received:

A) Supervisor Brown commented on her son's graduation from college.

B) Supervisor Williams requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of former Contra Costa County Supervisor Federal Glover.

C) Chair Mashburn commented on two trailer bills to the State Budget which are related to the Delta, noting they will gut CEQA with regard to any water project the State desires to put forward and limits litigation against the State or federal government with regard to issues around the environment when it comes to water projects. Chair Mashburn further stated there is every indication that the Governor will use these bills to push through the tunnel project. Chair Mashburn requested staff return with a presentation by the County's State lobbyist, with regard to any issues the State's budget will have on Solano County. Chair Mashburn further stated it is his desire that the County to an opposition position to the trailer bill, and he will be asking the cities to also take an opposition position to the trailer bill.

County Administrator Bill Emlen stated staff will return on June 10, 2025.

Supervisor Vasquez requested the federal lobbyist also be included in the presentation.

Supervisor Brown requested the federal lobbyist also bring information forward on the current administration's immigration policies.
