Dear Chair Mashburn and Members of the Board of Supervisors,

The Food Bank of Contra Costa and Solano writes to express our deep concern regarding the ongoing impacts of the federal government shutdown on CalFresh recipients in Solano County. The disruption to this critical nutrition program is already creating hardship for thousands of households and straining the emergency food network across our region.

As of November 1, 2025, more than **33,000 Solano County households** — and over **54,000 individuals** — experienced delays in receiving their CalFresh benefits, totaling more than **\$10 million in food assistance**. CalFresh is often the determining factor between food security and hunger, and even a temporary interruption intensifies hardship for the children, seniors, working families, immigrants, and federal workers who rely on it.

In response, **emergency food providers** — including the Food Bank, Food is Free Bay Area, and Catholic Charities — are serving unprecedented needs in communities across Solano County. At one Fairfield distribution alone, we saw 100 new families. We urge the Board to continue supporting these frontline organizations and to encourage people experiencing hunger to find an existing food distribution location at www.foodbankccs.org/findfood.

We also want to clarify that **Governor Newsom's recent announcement of \$80 million for California food banks reflects funding already included in the state budget**. While we are grateful for this support, **it is not sufficient to meet the surge in demand caused by CalFresh delays**.

Although the USDA announced plans to issue CalFresh benefits for November, and the State of California has issued November benefits, there appears to be **no clear plan for December**.

We respectfully call on the Solano County Board of Supervisors to agendaize a discussion on the emergency at hand at the November 18, 2025, meeting. Surrounding areas of Solano County are taking steps to address the harm that the shutdown is creating. On November 4, the Contra Costa County Board of Supervisors, in partnership with the Employment and Human Services Division, passed a resolution to fund **\$21 million in food benefits to residents through gift cards to be used at grocery retailers**. They plan to reserve these funds for December if the shutdown continues and benefits are again delayed or not issued. Additionally, the Napa County Board of Supervisors approved up to **\$1 million in emergency food assistance funding** to help households that rely on CalFresh. This includes grocery store gift cards. We ask the Board of Supervisors to explore similar avenues that work specifically for Solano County, to provide relief and prevent hunger in our community.

We remain committed to working alongside county leadership, nonprofit partners, and philanthropy until the government reopens. Together, we can help ensure families do not go hungry during this critical time and demonstrate the leadership and compassion that Solano County is known for.

Thank you for your continued partnership and dedication to serving our community.
