Enclosed please find Proof of Publication of the: "Notice Calling for Nominations for the Office of Trustee of Reclamation District No. 2136" and "Notice of No Election of Reclamation District No. 2136". Reclamation districts are required to hold elections on the first Tuesday following the first Monday in November in odd-numbered years. The "Notice Calling for Nominations" was published on September 1, 2017, which is not more than 75 days prior to the required election date nor less than 7 days prior to the 54th day before the election date. No nominations were received prior to 5:00 p.m. on the 54th day prior to the election (September 15th). If no nominations are received, the Board of Supervisors may appoint any qualified person as trustee.

The "Notice of No Election" was published on October 1, 2017, which was at least 30 days prior to the election date. This notice stated that no election will be held and that the Solano county Board of Supervisors will appoint the trustees.


