

**FIRST AMENDMENT TO STANDARD CONTRACT
BETWEEN COUNTY OF SOLANO AND PERSIMMONY INTERNATIONAL, INC.**

This First Amendment is made on March 28, 2017, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and Persimmon International, Inc. ("Contractor").

1. Recitals

- A. The parties entered into a Contract dated July 1, 2015 (the "Contract"), in which Contractor agreed to provide up to 29 user licenses and user support for MCAH programs.
- B. The County now needs to add 16 additional licenses and user support for TB/CD/STD/HIV programs.
- C. This First Amendment represents an increase of \$81,712 of the Contract.
- D. The parties agree to amend the Contract as set forth below.

Best Price Partner Discount Extension: During our first 3-Year contact, Solano County received our \$25,000 Best Price Discount applied over year's 1 and 2. An additional \$7,500 discount was provided beyond our Best Price Partner Discount for Year 3.

For this 3-Year Contract (2015-2018) Persimmony will continue to extend beyond our Best Price Partner \$25,000 Discount, providing a \$5,000 discount for Year 4 and a \$2,500 discount for Year 5. These additional discounts total \$15,000 (for Years 3, 4 and 5) combined with our Best Partner Discount of \$25,000 totals **\$40,000 in discounts** over years 1 to 5 for Solano County.
