Chief Information Officer Tim Flanagan provided a brief overview of the item.

Mr. Flanagan stated staff intends to file an informal objection with the California Public Utilities Commission (CPUC) Federal Funding Account (FFA) based on Solano County's statement of principle which is to first award grant applications to areas that are un-served and do not have a first choice for Broadband.

Chair Vasquez commented on the statement of principle stating it is exactly what the Board was requesting and to ensure the focus is not on the areas already receiving service but areas of the unincorporated that the Board represents.

Supervisor Mashburn stated there are rural areas within the County where there is no existing service and should receive funding priority.

Supervisor Brown stated CPUC should be viewing this process with an equity lens to ensure everyone is receiving service regardless of location.

On motion of Supervisor Mashburn, seconded by Supervisor Brown, the Board directed staff to file an informal objection with the California Public Utilities Commission (CPUC) Federal Funding Account, notifying the CPUC of Solano County's Statement of Principal to first award grant applications to areas that are un-served for broadband services. So ordered by a 5-0 vote.
