Senior Management Analyst Nancy Nelson introduced the item

Interim Fire Chief Arthur Gonzalez gave an overview of service provided by the East Vallejo Fire Protection District from Quarter 2 for FY2024/25.

Chair Mashburn congratulated Interim Fire Chief Gonzalez on his recent promotion.

In response to a question from Supervisor Williams regarding funding sources for the purchase of equipment, Interim Fire Chief Gonzalez provided an overview of the purchasing process with the City of Vallejo.

Supervisor Vasquez commented on the differences between the contracted services of the East Vallejo Fire Protection District and the upcoming changes with the Vacaville, Montezuma, and Suisun Fire Districts.

Chair Mashburn invited members of the public to address the Board on this matter. There was no public comment.

Principal Management Analyst Anne Putney introduced the item and provided an overview of the recommended updates to the county's user fees.

In response to a question from Supervisor Williams regarding increased fees in Environmental Health, Administrative Services Manager Sarah Pappakostas stated she believes Supervisor Williams was speaking about the boring fees, which were increased by at least double, noting that the actual cost is closer to four times what the County was currently charging.

Engineering Manager Mathew Tuggle stated that the State of California mandates permits for boring. Mr. Tuggle further stated there was an increase in several fees, where the actual cost to provide the service is considerably more than what the department has requested, noting that over the years, changes in laws have increased the costs associated with the services.

Director of Resource Management James Bezek stated the department ran a comparison with surrounding jurisdictions, and the recommended cost is in line with other counties.

Supervisor Williams requested in the future, staff provide more information regarding what the impacts of future increases will be.

Chair Mashburn opened and closed the public hearing with no comments from the public.

On motion of Supervisor Vasquez, seconded by Supervisor Brown, the Board adopted Resolution No. 2025-80 through Resolution No. 2025-98 revising fee schedules and amending the exhibits in Chapters 2.4 and 11 of the Solano County Code, revising and establishing various fees, to become effective July 1, 2025. Director of Resource Management James Bezek introduced the item.

Planning Program Manager Allan Calder provided an overview of the proposed amendments to Chapter 28 of the Solano County Code.

County Surveyor Chris Ferrucci provided an overview of the recommendation to

remove the requirement of private road maintenance agreements, returning the code to the same as current state law.

Mr. Bezek further provided information on the reason for the request to remove the requirement for road maintenance agreements, noting that many projects that would otherwise be acceptable have not moved forward due to the lack of a road maintenance agreement.

In response to a question from Supervisor Brown regarding road maintenance agreements, Mr. Bezek stated there is a secondary mechanism for citizens to deal with disagreements, noting this will take the civil matters out of the hands of county staff.

Supervisor Vasquez thanked staff for their efforts to clean up the code.

Mr. Calder provided an overview of the changes to sections V through X of the proposed ordinance related to farm stands.

A discussion period was held regarding the percentage rates of products sold at farm stands that must be grown or produced in Solano County.

Supervisor Williams commented in support of a consistent percentage of 25% throughout the county for the percentage requirement of goods grown or produced in Solano County to be sold at farm stands, noting she has concerns with fairness.

Chair Mashburn opened the public hearing and invited members of the public to address the Board on this matter and the following comments were received:

A) Lisa Howard speaking on behalf of the Suisun Vintners and Growers Association as well as Larry Balestra of Larry's Produce, noting Mr. Balestra is happy with the current requirement for locally grown and produced products of 25% for farm stands in his region. Ms. Howard further requested that the Board consider removing the statement "does not apply" to the larger farm stands. Ms. Howard further requested that the Board consider language that includes "produced onsite, offsite on land within Solano County, or in direct partnership," noting this provides flexibility but will still ensure at least 25% of the product sold is grown in Solano County.

B) Cliff Howard speaking on behalf of the Solano County Farm Bureau commented on additions to the ordinance related to the onsite growing requirements, noting the Farm Bureau does not agree with the onsite/offsite growing requirement that does not apply to farm stands larger than 2500 sq. ft. Mr. Howard further stated it would be difficult for the Farm Bureau to support a text amendment that does require produce or ag products to be grown in Solano County. Mr. Howard further stated that there needs to be a different definition of farm stands that sell a significant amount of product that is not grown in Solano County.

*C)* Gail Culley commented in support of the changes to the farm stand portion of the code and had questions regarding clarification on the potential costs related to road maintenance.

Mr. Bezek stated there are no fees related to road maintenance agreements, noting that any project that comes in going forward for subdivisions will need to submit a proper road maintenance agreement as per the new Road Standards and meet the requirements typical for subdivision applications.

### Chair Mashburn closed the public hearing.

Supervisor Williams restated her recommendation to have a countywide Solano grown product percentage requirement of 25% and encouraged the removal of exemptions for larger farm stands. Supervisor Williams further recommended that staff utilize subject matter experts when doing updates to the code.

In response to a question from Supervisor Vasquez regarding if staff has been given sufficient direction to clarify the differences in the various farm stands, Mr. Calder stated to work in a 25% locally grown number into farm stands over 2,500 square feet would be acceptable as long as it makes sense for the farmers and ranchers.

Mr. Bezek commented on the differences between the words local, Solano grown, and regional, noting the Board will need to come to a consensus on a term for staff to craft language for the ordinance.

Mr. Bezek commented on the need for more work with regard to Section IV of the proposed ordinance, noting that the changes that are being recommended are not under the purview of the public hearing being held at this meeting.

Chair Mashburn commented on the need to add language to the ordinance regarding regionalism, recommending the addition of the language "in partnership with", to reflect those growers that may grow product in a neighboring county while working with a Solano County grower, or a farmer from Solano County who leases land in a neighboring county because the particular crop they desire to grow, can not be produced in Solano County.

Chair Mashburn commented on the need for two different ordinances, stating he would like to see a clear delineation between the definitions of farm stand and local market.

Supervisor Williams requested clarification on what is considered regional. Supervisor Williams recommended that there be no waiver on the 25% locally grown product requirement for farm stands that are larger than 2,500 sq. ft. Supervisor Williams restated her recommendation that staff add in the recommended additions brought forward by the representatives from the Suisun Vintners and Growers Association and the Solano County Farm Bureau.

In response to a question from Mr. Calder regarding guidance on the wording

Solano grown vs regional, Chair Mashburn stated Solano grown means things that are produced in Solano County, by Solano County farmers, whether it is grown on Solano County land or is produce that was grown through their agricultural business outside of Solano County. Chair Mashburn further stated all of the product produced by the Solano County farmer, regardless of if it is was grown on Solano County land should be considered a portion of the 25% requirement.

Supervisor Brown commented on the need to clarify what is considered regional.

Supervisor Vasquez commented on the need to separate out the differences between what is allowed in the zoning of agricultural land vs. commercial zoned land. Supervisor Vasquez further stated it is difficult for him to tell farmers what they have to produce.

A discussion period was held regarding the difference between regional and locally grown.

Supervisor Williams commented on the need to keep products that are locally grown, noting that she has concerns over the idea of a regional approach when it comes to wine grape crops in particular.

County Counsel Bernadette Curry stated the motions should indicate that the Board is recommending the approval of Sections I-IV and the elimination of Sections V-X of the ordinance.

On motion of Chair Mashburn, seconded by Supervisor Vasquez, the Board: 1) amended the ordinance by removing sections V-X; 2) read the proposed amended ordinance by title only and waived further reading by majority vote; and 3) adopted Ordinance No. 2025-1861 amending Chapter 28 (Zoning Regulations) of the Solano County Code to revise and update sections pertaining to general development standards, agricultural accessory buildings, and land uses on private roads (ZT-25-01). So ordered by a 5-0 vote.

Chair Mashburn stated the presentation is being brought forward at the request of the Board, noting that it provides the Board and the public with the opportunity to hear exactly what is in the General Plan and exactly what is and is not designated as approved land uses in the region.

Director of Resource Management James Bezek introduced the item and provided information on the Collinsville Special Study Area.

Water and Natural Resources Program Manager Misty Kaltreider provided information on the Water Dependent Industrial Areas.

Chair Mashburn invited members of the public to address the Board on this matter and the following comments were received:

A) Dwight Calloway commented on potential security issues, and in support of the potential of a shipyard in Collinsville

*B)* Eunice Mallery commented in opposition to the County working with California Forever on a potential shipbuilding project in Solano County.

*C)* Joel Barrilleaux commented in opposition to the County working with California Forever on a potential shipbuilding project in Solano County.

D) Michael Hayes commented in opposition to a potential shipbuilding project in Solano County.

*E)* Jim Bartz commented in opposition to a potential shipbuilding project in Solano County

*F)* Jan Bartz commented in opposition to a potential shipbuilding project in Solano County.

*G)* Terry Tucker commented in opposition to the County working with California Forever on a potential shipbuilding project in Solano County.

*H)* Margaret Anderson commented on the potential impacts of a shipbuilding project in Solano County.

*I)* Marilyn Farley commented on the potential impacts of a shipbuilding project in Solano County

Supervisor Vasquez stated this item is simply a presentation of what is possible under the current General Plan. Supervisor Vasquez further stated from his perspective, this issue should be taken up during the the General Plan review. J) Former Supervisor Duane Kromm commented on the need for the public to hear data points related to the depth of the shipping channels in the Collinsville area and information regarding how much dredging will be required to accommodate the type of ships they are planning to build.

Supervisor Vasquez stated the first step in this process should be a countywide summit, so the cities can state what their future development plans are for the next 10-20 years, noting that at some point, this discussion needs to be heard by the Board and the public. Supervisor Vasquez further stated that at this time, this is no pending application for a project.

Supervisor Williams commented in support of Supervisor Vasquez's comments, noting she would like more information on potential funding for any projects. Supervisor Williams further commented on the need for California Forever to work with the county on any potential proposal. Supervisor Williams further stated the county should be working with Congressman Garamendi, who is focused more heavily on Mare Island, and further noted that she would like the cities to allow the county to work through this process.

Supervisor Brown commented on the need for everyone to wait and see how this situation pans out, noting that the Executive Order does not have funding attached to it.

Supervisor James commented on the need to distinguish the difference between the Ships Act and the Executive Order.

In response to Supervisor James's comments, Mr. Bezek stated the Executive Order identified goals to bring back maritime opportunities that can align with the Collinsville area and the General Plan. Mr. Bezek further stated that there has been no analysis as to what that could mean to Solano County because there has not been a project brought forward. Mr. Bezek further stated the Ships Act is a bipartisan effort that is still in process with goals that are similar to the Executive Order but more focused at the national level. Mr. Bezek further stated that California Forever has held virtual town halls to describe what they would like to see in the Collinsville area, which created a lot of excitement within the cities and the media.

Chair Mashburn stated the County has a landowner that has had some controversy surrounding it and there is stigma attached to that name for good or bad. Chair Mashburn further stated prior to California Forever owning the land it was owned by others, noting that regardless of who owns the land, they will still be required to bring any project forward and go through a specific process with many regulatory agencies to make the project happen. Chair Mashburn noted that once that is complete, they would have to bring the proposal to the county for review. Chair Mashburn further stated that this is a valid use of the land per the county's current General Plan. Chair Mashburn further stated he fully supports the concept of there being some type of shipbuilding industry or manufacturing brought to the Solano County region; however, there is a need to separate the excitement of the cities over the possibilities from the process, which is solely at this time a county process. Chair Mashburn commented on the upcoming work to be completed on the General Plan review, noting that everyone needs to work together as a region to come up with a plan that makes sense and is strategic. Chair Mashburn further stated the County needs to see where the funding is going to come from and will need a true plan, regardless of where it is going to be built. Chair Mashburn asked that the cities take a step back to ensure the county has the ability to follow the process that needs to take place. Chair Mashburn commented on the need to make sure control stays with the County to ensure the local jurisdictions continue to have a say in their future. Chair Mashburn directed staff to begin the process of creating the county summit session.

Chair Vasquez provided a brief history of the Collinsville area.

Supervisor Williams commented on the need to remember the City of Vallejo in this process and on the need for the Board to have a good understanding of the process before beginning to work with the cities.
