RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS ADOPTING REVISED BOUNDARIES FOR SUPERVISORIAL DISTRICTS FOLLOWING THE 2020 FEDERAL CENSUS IN ACCORDANCE WITH CALIFORNIA ELECTIONS CODE SECTION 21500, ET SEQ.

WHEREAS, following each federal decennial census the County of Solano must adopt boundaries for all of the supervisorial districts of the county with any necessary revisions so that the supervisorial districts shall be substantially equal in population as required by the United States Constitution; and

WHEREAS, Elections Code sections 21500 through 21509 set forth the criteria, requirements, procedures and deadlines for the adoption of supervisorial district boundaries following the release of census data on or before December 15, 2021; and

WHEREAS, Elections Code section 21500 provides that supervisorial districts may be adopted by ordinance or resolution; and

WHEREAS, Solano County Code Chapter 1.4 contains the legal descriptions of the Supervisorial district boundaries,

WHEREAS, in accordance with Election Code section 21500; after conducting duly noticed public meetings and hearings wherein all members of the public were provided the opportunity to provide input regarding proposed supervisorial district boundaries on December 7, 2021, the Board of Supervisors introduced an ordinance which repeals the boundaries established in 2011 and on December 14, 2021, the Board of Supervisors adopted Ordinance No. 1826 establishing new boundaries reflecting the 2020 Federal Decennial Census.

NOW THEREFORE BE IT RESOLVED, by the Solano County Board of Supervisors finds that the required duly noticed public meetings and hearings have been held before and after the drawing of supervisorial district boundaries in accordance with Elections Code section 21507.1.

BE IT FURTHER RESOLVED that the County of Solano took steps to encourage residents to participate in the redistricting public review process in accordance with Elections Code section 21508.

BE IT FURTHER RESOLVED that Solano County adopts the supervisorial district boundaries for each district set forth in the legal description set forth in Ordinance No. 1826 (Attachment A), and as depicted on the map in Attachment B.

BE IT FURTHER RESOLVED that the district boundary descriptions and map shall be posted on the County of Solano website. These maps shall graphically depict the Supervisorial Districts and are and shall be known as the Official Supervisorial District Maps of Solano County. To the extent that any conflict exists between or among the legal descriptions in Attachment A and the Official Supervisorial District Maps of Solano County as shown on Attachment B and as posted on the County of Solano website as a result of technical or clerical error in the descriptions or as a result of property lines not conforming to census block descriptions, the official legal descriptions shall control.
