RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING JACKSON F. HARRIS, DEPUTY DISTRICT ATTORNEY, UPON HIS RETIREMENT FROM THE SOLANO COUNTY DISTRICT ATTORNEY'S OFFICE WITH OVER 34 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY

WHEREAS, Jackson F. Harris (Jack) began his career with the Solano County on January 3, 1983, as a Deputy District Attorney under District Attorney Michael E. Nail; and

WHEREAS, Jack has held assignments in the Misdemeanor Unit, Felony Trial Team, Juvenile Unit, Family Support Division, Career Criminal Unit, Criminal Charging Deputy (Felonies and Misdemeanors), SOLNET/Cal-MMET/Drug Task Force and was the senior attorney in the Prison Prosecution Unit for the last 26 years; and

WHEREAS, Jack served under four District Attorneys throughout his career: Michael E. Nail 1986-1993, David W. Paulson 1993-2010, Donald A. du Bain 2011-2014, and Krishna A. Abrams 2014-present; and has made many contributions to the District Attorney's Office and was promoted to Deputy District Attorney V in 1991 under Michael E. Nail; and

WHEREAS, Jack has been a friend and mentor to his colleagues, sharing his knowledge, skills and experience and he has earned the respect and admiration of his colleagues in the District Attorney's Office, the peace officers of Solano County, and law enforcement professionals throughout the State of California; and

WHEREAS, Jack was regarded as the office resource in legal research and was commended for serving as an instructor for the California District Attorneys Association during the 2000-2001 training year; and

WHEREAS, he has exhibited a dedication to the law, the pursuit of justice, and the residents of Solano County; and

WHEREAS, Jack has always showed his love for his family and rock & roll music, and often times he would share anecdotes about his family, and often times you would hear him blaring his music in the parking garage or talking about his favorite songs; and

WHEREAS, Jackson F. Harris, a longtime resident of Solano County, retired on April 7, 2017, after more than 34 years of service to the Solano County District Attorney's Office.
