**RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS  
APPROVING REVENUE AGREEMENTS AND DELEGATING AUTHORITY TO THE  
COUNTY ADMINISTRATOR OR DESIGNEE TO EXECUTE REVENUE  
AGREEMENTS AND MEMORANDUM OF UNDERSTANDINGS; AND DELEGATING  
AUTHORITY TO THE DIRECTOR OF HEALTH AND SOCIAL SERVICE TO EXECUTE  
INDIVIDUAL ADMISSION AGREEMENTS FOR **RESIDENTIAL TREATMENT,**  
BOARD AND CARE, **ANY OTHER TREATMENT** FACILITY PLACEMENTS, AND  
INDIVIDUAL AGREEMENTS FOR SUBSTANCE ABUSE TREATMENT  
PLACEMENTS **AS NECESSARY WITHIN BUDGETED APPROPRIATION****

**Whereas,** the Solano County Board of Supervisors recognizes that the Department of Health and Social Services receives routine revenue agreements from various Departments of the State of California including the Department of Health Services; the Department of Rehabilitation; and other State agencies throughout the fiscal year; and

**Whereas,** the State of California requires a resolution authorizing approval and authorizing the County Administrator to execute the revenue agreements and any resulting amendments; and

**Whereas,** the Department of Health and Social Services has other multiple federal, State, and other standard revenue agreements and Memorandum of Understandings that are submitted during the fiscal year and require the flexibility of execution so as to receive funding and services in a timely manner; and

**Whereas,** the Mental Health Division of the Department of Health and Social Services has a need to place mentally ill clients in board and care facilities **and other residential treatment facilities** in a timely manner to ensure proper treatment and such placements are done with individual admission agreements to the facilities; and

**Whereas,** the Substance Abuse Division of the Department of Health and Social Services has a need to place clients in substance abuse treatment services in a timely manner to ensure proper treatment and such placements are done with individual admission agreements to the facilities.

**Resolved,** that the Solano County Board of Supervisors hereby authorizes approval of the State of California revenue agreements and authorizes the County Administrator or designee to execute said agreements and amendments provided that no changes will negatively impact the County General Fund.

**Further resolved**, that the Solano County Board of Supervisors hereby delegates authority to the County Administrator or designee to execute revenue agreements and Memorandum of Understandings **which are included in the FY2017/18 budget or have no budget impact**; and delegates authority to the Director of Health and Social Services or designee to execute individual admission agreements, **including authorizations for services for clients place in residential treatment facilities, board and care facilities, any other treatment facilities as necessary**, and individual admission agreements for substance abuse treatment placements **within FY2017/18 budget appropriations**.
