I. CONTRACT SUMMARY INFORMATION:

II. INTENT OF THIS CONTRACT

The purpose of this Contract is for Interactive Technology Services Inc., (Contractor) to provide Network Administration, Help Desk Support, Server Upgrades and Maintenance on behalf of the Workforce Development Board (WDB) of Solano County. The array of services provided by the Contractor are described in detail under the Section D.4 Administration — Deliverables. The contract shall commence on October 1, 2016 and shall end of September 30, 2017. Total contract award for this 12 month period will not exceed \$47,785.

Disaster Recovery and Emergency Services are not within the Intent of this contract. A Disaster Recovery or Emergency Services is defined as an unforeseeable act or event, such as a natural disaster, which renders the network inoperable. In such an event, the WDB and Contractor will negotiate a separate contract.

III. <u>DEFINITIONS:</u>

A. MODIFICATIONS

This Contract and its exhibits may be modified or amended only by a written instrument signed by both parties.

B. <u>SERVICE AREA</u>

Services will be provided by the Contractor at the following two WDB locations within Solano County:

320 Campus Lane Fairfield, CA 94534

1440 Marin Street Vallejo, CA 94590

C. INSPECTION AND AUDIT

The Contractor shall maintain auditable records supporting payments made under this Contract. The Contractor's performance and records pertaining to this Contract are subject to monitoring, inspection, review and audit by authorized representatives of the WDB, the Employment Development Department of the State of California, or the U.S. Department of Labor, at the Contractor's place of business, upon reasonable notice, during the Contractor's normal business hours. These records shall be retained for a period of three (3) years from the date of the final payment of WDB grant funds through this Contract, or beyond that date, if any audit findings remain unresolved.

D. SUBCONTRACTING

The services to be provided by the Contractor under this Contract are personal in nature and shall not be subcontracted or assigned to any firm or non-contract staff without the prior written approval of the WDB.

E. PUBLICATIONS, PRESENTATIONS AND PRODUCT DEVELOPMENT

The Contractor and every officer, director, employee, or agent of the Contractor, in making presentations to the media, in any discussion of the activities conducted under this contract in any public forum, in publishing work, or producing or creating any product or material for either public or private use relating to the scope of work described in this contract, shall conspicuously acknowledge the WDB's participation in these activities and that such activities and related products and materials supported by funds provided through this contract with the WDB. The WDB reserves the right of approval of all publications, public presentations, and product development. Copies of all publications and notifications of public presentations and product or materials availability shall immediately be sent to the WDB's President/Executive Director for prior approval.

F. RIGHTS IN DATA AND COPYRIGHTS

The WDB shall retain all rights in data, reports, and other products resulting from services provided by the Contractor through this contract, unless otherwise agreed in writing. Contractor relinquishes any and all copyrights to any materials produced in whole or in part, under the terms of this contract. WDB is entitled to publish reports and/or documents. All reports, data and other materials prepared under this Agreement shall become the exclusive property of the WDB upon submission to the WDB.

G. FACILITES AND EQUIPMENT

Except as provided Contractor shall, at its sole cost and expense, furnish all facilities and equipment which may be required for providing services pursuant to this Contract. The WDB shall furnish physical facilities, such as desks and conference space, as may be reasonably necessary for the Contractor's use while consulting with WDB employees, performance of some deliverables outlined within this contract, and when reviewing records and information in possession of the WDB. The location, quality, and time of furnishing said facilities shall be at the sole discretion of the WDB. In no event shall the WDB be obligated to furnish any facility which may involve incurring any direct expense, including but not limiting the generality of this exclusion to, long-distance telephone or other communication charges, vehicles and reproduction facilities.

H. WARRANTY

WDB relies upon Contractor's professional ability and training as a material inducement to enter into this Contract. Contractor warrants that it will perform the work according to generally accepted professional practices and standards and the requirements of applicable federal, state and local laws. WDB's acceptance of Contractor's work shall not constitute a waiver or release of Contractor from professional responsibility.

IV. CONTRACTOR SHALL BE RESPONSIBLE FOR THE FOLLOWING DUTIES:

A. AVAILABILITY TO PERFORM SERVICES

- a. Provide and train qualified staff to plan and administer the contracted services;
- b. Provide service sustainability for duration of contract; and,
- **c.** Provide services during scheduled business days and/or hours appropriate to program participants' needs.

B. SERVICE ACTIVITIES

Contractor is providing WDB comprehensive, full service hardware and software service and support. Normal network configuration changes to accomplish the relocation of personnel and application changes as well as WDB business requirements will be performed includes maintaining the servers, WAN and Internet connections, PC client application, upgrading virus and spy ware protections and training and supporting WDB staff.

C. RESPONSE TIME

Contractor will provide all scheduled work associated with this contract during normal business hours of Monday-Friday, 8:00 a.m. – 5:00 p.m.

Minimum service call is defined as one (1) billable hour and all billings are based on actual man hours. Contract hours totaling 398.2 for this 12 month period have been calculated at the standard hourly rate of \$120.00. Should there be a need to charge at the higher rates as described in Exhibit B, those costs will be subtracted from the maximum contract award of \$47,785.

Responsiveness requirements are in two tiers:

- Tier One Network issue causing significant impact of the agency fulfilling its mission – <u>Immediate Response Required.</u>
- Tier Two Network inconvenience staff work around possible telephone 4 hours and on-site response within 24 hours.
- Please Note: A physical presence on-site will be required upon request.

D. ADMINISTRATION

1. Maintenance of Effort

Contractor assures that services provided and funds received under this Contract will not supplant existing services or funds allocated for the same purpose.

2. Successors

Inasmuch as it affects this Contract, should the Contractor sell or otherwise relinquish all of any portion of the ownership of the Contractor corporation during the course of this Contract, any future owner(s) of the corporation will agree to be bound by the provisions stipulated herein for the length of the contract.

3. Time is of the Essence of this Contract

Time is of the essence in all terms and conditions of this contract.

4. Deliverables

The Contractor shall conduct/provide the following specific services, activities and products under this contract according to the following schedule.

Network Administration

- Schedule necessary time for dedicated Network Administration and maintenance will be scheduled and approved by the WDB Network Coordinator.
- All services will be provided in a manner not to disrupt normal business operations.

Scope of Work includes all of the following – as needed, as requested:

- Maintain Servers as required.
- Upgrading the servers to accommodate growth or changes in hardware and/or software.
- Maintaining back-up systems for agency data.
- Upgrading and maintaining virus protection.
- Minimizing SPAM.
- Maintaining the Internet and Wi-Fi connections.
- Maintaining clients PC's.
- Upgrading clients PC's to accommodate growth or changes in hardware and/or software.
- Installing and maintaining necessary network cables.
- Regularly scheduled visits (to be determined).
- Network administration and Help Desk support.
- Training and supporting staff in efficiently using these resources.

- The above amounts are contingent upon acceptance of an appropriately working and usable system and shall be in compensation for all time and expenses incurred by the Contractor. The Contractor will not be reimbursed for any out of pocket costs.
- 2. The Contractor shall submit monthly invoices detailing work performed for each deliverable detailed in the Scope of Work (Exhibit A) and amount payable to the WDB's Executive Director/President. The payment shall be made only after the services required under this contract have been performed to the satisfaction of the Executive Director/President, and the deliverables described in Exhibit A, Scope of Work, have been accepted in writing by the Executive Director/President of his/her designee.
- 3. The Contractor shall provide any additional documentation as required by WDB at any time in order to substantiate Contractor claims for payment. WDB may elect to withhold payment for failure by Contractor to provide such documentation required by WDB.
- 4. The maximum payment under the terms of this contract shall under no circumstances, exceed \$84,745 for the related expenses unless this contract is modified in accordance with Section XVI in Exhibit C.

General Terms and Conditions

1. Closing Out

The WDB-SC will pay the Contractor's final request for payment providing Contractor has paid all financial obligations undertaken pursuant to this Contract. If Contractor has failed to pay all obligations outstanding, WDB-SC will withhold from the Contractor's final request for payment, the amount of such outstanding financial obligations owed by Contractor. Contractor is responsible for WDB-SC's receipt of a final request for payment 30 days after termination of this contract.

2. Time

Time is of the essence in all terms and conditions of this Contract.

3. Time of Performance

Work will not begin, nor claims paid for services under this Contract until all Certificates of Insurance, business and professional license/certificates, IRS ID number, signed W-9 form, or other applicable licenses or certificates are on file with the WDB-SC's Planning Unit.

4. Termination

- A. This Contract may be terminated by WDB-SC or Contractor, at any time with or without cause, upon 30 days written notice from one to the other.
- B. WDB-SC may terminate this Contract immediately upon notice of Contractor's malfeasance.
- C. Following termination, WDB-SC will reimburse Contractor for all expenditures made in good faith that are unpaid at the time of termination not to exceed the maximum amount payable under this Contract unless Contractor is in default of this Contract.

5. Signature Authority

The parties executing this Contract certify that they have the proper authority to bind their respective entities to all terms and conditions set forth in this Contract.

6. Representations

- A. WDB-SC relies upon Contractor's professional ability and training as a material inducement to enter into this Contract. Contractor represents that Contractor will perform the work according to generally accepted professional practices and standards and the requirements of applicable federal, state and local laws. WDB-SC's acceptance of Contractor's work shall not constitute a waiver or release of Contractor from professional responsibility.
- B. Contractor further represents that Contractor possesses current valid appropriate licensure, including, but not limited to driver's license, professional license, certificate of tax-exempt status, or permits, required to perform the work under this Contract.

7. Insurance

A. Without limiting Contractor's obligation to indemnify WDB-SC, Contractor must procure and maintain for the duration of the Contract insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work under this Contract and the results of that work by Contractor, Contractor's agents, representatives, employees or subcontractors.

B. Minimum Scope of Insurance:

Coverage must be at least as broad as:

- (1) Insurance Services Office Commercial General Liability coverage (occurrence Form CG 00 01)
- (2) Insurance Services Office Form Number CA 00 01 covering Automobile Liability, code 1 (any auto)
- (3) Workers' Compensation insurance as required by the State of California and Employer's Liability Insurance.
- C. Minimum Limits of Insurance Contractor must maintain limits no less than

D. Additional Insurance Coverage

To the extent coverage is applicable to Contractor's services under this Contract, Contractor must maintain the following insurance coverage:

Cyber Liability:	\$1,000,000	per incident with the aggregate limit of twice the required limit

E. If Contractor maintains higher limits than the minimums shown above, WDB-SC is entitled to coverage for the higher limits by Contractor.

F. Deductibles and Self-Insured Retentions

Any deductibles or self-insured relations must be declared to and approved by the WDB-SC. At the option of the WDB-SC, either:

- (1) The insurer will reduce or eliminate such deductibles or self-insured retentions with respect to WDB-SC, its officers, officials, agents, employees and volunteers; or;
- (2) Contractor must provide a financial guarantee satisfactory to WDB-SC guaranteeing payment of losses and related investigations, claim administration, and defense expenses.

G. Other Insurance provisions

The general liability and automobile liability policies must contain, or be endorsed to contain, the following provisions:

- (1) The WDB-SC of Solano County, its officers, officials, agents, employees, and volunteers must be included as additional insured with respect to liability arising out of automobiles owned, leased, hired or borrowed by or on behalf of Contractor; and with respect to liability arising out of work or operations performed by or on behalf of Contractor including materials, parts or equipment furnished in connection with such work or operations. General Liability coverage shall be provided in the form of an Additional Insured endorsement. The insurance afforded to the additional insured shall be at least as broad as that afforded to the first named insured.
- (2) For any claims related to work performed under this Contract, Contractor's insurance coverage must be primary insurance with respect to the WDB-SC of Solano County, its officers, agents, employees, or volunteers is excess of Contractor's insurance and shall not contribute to it.
- (3) Should any of the above described policies be cancelled prior to the policies' expiration date, Contractor agrees that notice of cancellation will be delivered in accordance with the policy provisions.

H. Waiver of Subrogation

- (1) Contractor agrees to waive subrogation which any insurer of Contractor may acquire from Contractor by virtue of the payment of any loss. Contractor agrees to obtain any endorsement that may be necessary to affect this waiver of subrogation.
- (2) The Workers' Compensation policy must be endorsed with a waiver of subrogation in favor of the WDB-SC for all work performed by Contractor, its employees, agents and subcontractors.

Acceptability of Insurers

Insurance is to be placed with insurers with a current A.M. Best's rating of no less than A:VII unless otherwise acceptable to the WDB-SC.

J. Verification of Coverage

- (1) Contractor must furnish WDB-SC with original certificates and endorsements effecting coverage required by this Contract.
- (2) The endorsements should be on forms provided that conform to the WDB-SC's requirements and acceptable to the WDB-SC.
- (3) WDB-SC must receive and approve all certificates and endorsements before work commences.
- (4) However, failure to do so shall not operate as a waiver of these insurance requirements.
- (5) WDB-SC reserves the right to require complete, certified copies of all required insurance policies, including endorsements affecting the coverage required by these specifications at any time.

8. Best Efforts

Contractor represents that Contractor will at all times faithfully, industriously and to the best of its ability, experience and talent, perform to the WDB-SC's reasonable satisfaction.

9. Default

- A. If Contractor defaults in Contractor's performance, WDB-SC shall promptly notify Contractor in writing. If Contractor fails to cure a default within 30 days after notification or if the default requires more than 30 days to cure and Contractor fails to commence to cure the default within 30 days after notification, then Contractor's failure shall terminate this Contract.
- B. If Contractor fails to cure default within the specified period of time, WDB-SC may elect to cure the default and any expense incurred shall be payable by Contractor to WDB-SC.
- C. If WDB-SC serves Contractor with a notice of default and Contractor fails to cure the default, Contractor waives any further notice of termination of this Contract.
- D. If this Contract is terminated because of Contractor's default, WDB-SC shall be entitled to recover from Contractor all damages allowed by law.

10. Indemnification

A. Contractor will indemnify, hold harmless and assume the defense of the WDB-SC, its officers, employees, agents and board members from all claims, losses, damages, including property damages, personal injury, death and liability of every kind, directly or indirectly arising from Contractor's operations or from any persons directly or indirectly employed by, or acting as agency for, Contractor, excepting the negligence or willful misconduct of the WDB-SC. This indemnification shall extend to claims, losses, damages, injury and liability for injuries occurring after completion of Contractor's services, as well as during the progress of rendering such services.

B. Acceptance of insurance required by this Contract does not relieve Contractor from liability under this indemnification clause. This indemnification clause shall apply to all damages or claims for damages suffered by Contractor's operations regardless if any insurance is applicable or not.

11. Independent Contractor

- A. Contractor is an independent contractor and not an agent, officer or employee of the WDB-SC. The parties mutually understand that this Contract is between two independent contractors and is not intended to and shall not be construed to create the relationship of agent, servant, employee, partnership, joint venture or association.
- B. Contractor shall have no claim against WDB-SC for employee rights or benefits including, but not limited to, seniority, vacation time, vacation pay, sick leave, personal time off, overtime, medical, dental or hospital benefits, retirement benefits, Social Security, disability, Workers' Compensation, unemployment insurance benefits, civil service protection, disability retirement benefits, paid holidays or other paid leaves of absence.
- C. Contractor is solely obligated to pay all applicable taxes, withholding, Social Security, unemployment, disability insurance, Worker's Compensation and Medicare payments.
- D. Contractor shall indemnify and hold WDB-SC harmless from any liability which WDB-SC may incur because of Contractor's failure to pay such obligations, as set forth in this paragraph.
- E. As an independent contractor, Contractor is not subject to the direction and control of the WDB-SC except as to the final result contracted for under this Contract. WDB-SC may not require Contractor to change Contractor's manner of doing business, but may require redirection of efforts to fulfill this Contract.
- F. Contractor may provide services to others during the same period Contractor provides service to WDB-SC under this contract.
- G. Any third persons employed by Contractor shall be under Contractor's exclusive direction, supervision and control. Contractor shall determine all conditions of employment including hours, wages, working conditions, discipline, hiring and discharging or any other condition of employment.
- H. As an independent contractor, Contractor shall indemnify and hold WDB-SC harmless from any claims that may be made against WDB-SC based solely on the contention by a third party that an employer-employee relationship exists under this Contract. Notwithstanding this provision, to the extent that any claim, as described in this subsection, is based on alleged negligence or willful misconduct of WDB-SC, Contractor shall have no duty to indemnify and hold WBD-SC harmless for that particular claim.
- I. Contractor, with full knowledge and understanding of the foregoing, freely, knowingly, willingly and voluntarily waives the right to assert any claim to any right or benefit or term or condition of employment insofar as they may be related to or arise from compensation paid hereunder.

12. Responsibilities of Contractor

A. The parties understand and agree that Contractor possesses the requisite skills necessary to perform the work under this Contract and WDB-SC relies upon such skills. Contractor pledges to perform the work skillfully and professionally. WDB-SC's acceptance of Contractor's work does not constitute a release of Contractor from professional responsibility.

- B. Contractor verifies that Contractor has reviewed the scope of work to be performed under this Contract and agrees that the contractor's professional judgment, the work can and shall be completed for costs within the maximum amount set forth in this Contract.
- C. To fully comply with the terms and conditions of this Contract, Contractor shall:
- (1) Establish and maintain a system of accounts for budgeted funds that complies with generally accepted accounting principles for government agencies;
- (2) Document all costs by maintaining complete and accurate records of all financial transactions associated with this Contract, including, but not limited to, invoices and other official documentation that sufficiently support all charges under this Contract;
- (3) Submit monthly reimbursement claims for expenditures that are directly associated with the NBBSA grant;
- (4) Be liable for repayment of any disallowed costs identified through quarterly reports, audits, monitoring or other sources; and,
- (5) Retain financial, programmatic, client data and other service records for three (3) years from the date of the end of the contract award or for three (3) years from the date of termination, whichever is later.

13. Compliance with Law

- A. Contractor shall comply with all federal, state and local laws and regulations applicable to Contractor's performance, including, but not limited to, licensing, employment and purchasing practices, wages, hours and conditions of employment.
- B. Contractor represents that it will comply with the applicable cost principles and administrative requirements including claims for payment or reimbursement by WDB-SC as set forth in 2 CFR 200, as currently enacted or as may be amended throughout the term of this Contract.

14. Confidentiality

- A. Contractor shall prevent unauthorized disclosure of names and other client-identifying information, except for statistical information not identifying a particular client.
- B. Contractor shall not use client specific information for any purpose other than carrying out Contractor's obligations under this Contract.

C. Contractor shall promptly transmit to WDB-SC all requests for disclosure of confidential information related to this Contract.

- D. Except as otherwise permitted by this Contract or authorized by the client, Contractor shall not disclose any confidential information related to this Contract to anyone other than the State of California without prior written authorization from WDB-SC.
- E. For purposes of this section, identity shall include, but not be limited to, name, identifying number, symbol or other client identifying particulars, such as fingerprints, voice print or photography. Client shall include individuals receiving services pursuant to this Contract.

15. Conflict of Interest

A. Contractor represents that Contractor and/or Contractor's employees and/or their immediate families and/or Board of Directors and/or officers have no interest, including, but not limited to, other projects or independent contracts, and shall not acquire any interest, direct or indirect, including separate contracts for the work to be performed hereunder, which conflicts with the rendering of services under this Contract. Contractor shall employ or retain no such person while rendering services under this Contract. Services rendered by Contractor's associates or employees shall not relieve Contractor from personal responsibility under this clause.

B. Contractor has an affirmative duty to disclose to the WDB-SC in writing the name(s) of any person(s) who have an actual, potential or apparent conflict of interest.

16. Drug Free Workplace

Contractor represents that Contractor is knowledgeable of Government Code section 8350 et seq., regarding a drug free workplace and shall abide by an implement its statutory requirements.

17. Health and Safety Standards

Contractor shall abide by all health and safety standards set forth by the State of California.

18. Child/Adult Abuse

If services pursuant to this Contract will be provided to children and/or elder adults, Contractor represents that Contractor is knowledgeable of the Child Abuse and Neglect Reporting Act (Penal Code section 11164 et seq.) and the Elder Abuse and Dependent Adult Civil Protection Act (Welfare and Institutions Code section 15600 et. seq.) requiring reporting of suspected abuse.

19. Inspection

Authorized representatives of WDB-SC, the State of California and/or the federal government may inspect and/or audit Contractor's performance, place of business and or records pertaining to this Contract.

20. Nondiscrimination

A. In rendering services under this contract, Contractor shall comply with all applicable federal, state and local laws, rules and regulations and shall not discriminate

based on age, ancestry, color, gender, marital status, medical condition, national origin, physical or mental disability, race, religion, sexual orientation or other protected status.

B. Further, Contractor shall not discriminate against its employees, which includes but is not limited to, employment upgrading, demotion or transfer, recruitment or recruitment advertising, layoff or termination, rates of pay or other forms of compensation and selection for training, including apprenticeship.

21. Subcontractor and Assignment

- A. Services under this Contract are deemed to be personal services.
- B. Contractor shall not subcontract any work under this Contract nor assign this Contract or monies due without the prior written consent of the WDB-SC's Business & Resource Services Manager, applicable Division Manager or his her designee and the President/Executive Director subject to any required state or federal approval.
- C. If WDB-SC consents to the use of subcontractors, Contractor shall require and verify that its subcontractor maintain insurance meeting all of the requirements stated in Section 7 above.
- D. Assignment by Contractor of any monies due shall not constitute an assignment of the Contract.

22. Unforeseen Circumstances

Contractor is not responsible for any delay caused by natural disaster, war, civil disturbance, labor dispute or other cause beyond Contractor's reasonable control, provided Contractor gives written notice to WDB-SC of the cause of the delay within ten (10) days of the start of the delay.

23. Notice

- A. Any notice necessary to the performance of this Contract shall be given in writing by personal delivery or by prepaid first-class mail addressed as stated on the first page of this Contract.
- B. If notice is given by personal delivery, notice is effective as of the date of personal delivery. If notice is given by mail, notice is effective as of the day following the date of mailing or the date of delivery reflected upon a return receipt, whichever occurs first.

24. Nonrenewal

Contractor acknowledges that there is no guarantee that WDB-SC will renew Contractor's services under a new contract following expiration or termination of this Contract. Contractor waives all rights to notice of non-renewal of Contractor's service.

25. WDB-SC's Obligation Subject to Availability of Funds

A. The WDB-SC's obligation under this Contract is subject to the availability of authorized funds. The WDB-SC may terminate the Contract, or any part of the Contract work, without prejudice to any right or remedy to the WDB-SC, for lack of appropriation of funds. If expected or actual funding is withdrawn, reduced or limited in any way prior to the expiration date set forth in this Contract, or any subsequent amendment, the

WDB-SC may, upon written Notice to the Contractor, terminate this Contract in whole or in part.

- B. Payment shall not exceed the amount allowable for appropriation by the Board of Directors of the Workforce Development Board of Solano County and ratified by the County of Solano Board of Supervisors (over \$50,000). If the Contract is terminated for non-appropriation of funds:
- i. The WDB-SC will be liable only for payment in accordance with the terms of this Contract for services rendered prior to the effective date of termination; and,
- ii. The Contractor shall be released from any obligation to provide further services pursuant to this Contract that are affected by the termination.
- C. Funding for this Contract beyond the current appropriation year is conditional upon appropriation by the Board of Directors of the Workforce Development Board of Solano County of sufficient funds to support the activities described in this Contract. Should such an appropriation not be approved, this Contract will terminate at the close of the current Appropriation Year.
- D. This Contract is void and unenforceable if all or parts of federal or state funds applicable to this Contract are not available to the WDB-SC. If applicable funding is reduced, WDB-SC may either:
 - (1) Cancel this Contract; or,
 - (2) Offer a contract amendment reflecting the reduced funding.

26. Changes and Amendments

- A. WDB-SC may request changes in Contractor's scope of service. Any mutually agreed upon changes, including any increase or decrease in the amount of Contractor's compensation, shall be effective when incorporated in written amendments to this Contract.
- B. The party desiring the revision shall request amendments to the terms and conditions of this Contract in writing. Any adjustment to this Contract shall be effective only upon the parties' mutual execution of an amendment in writing.
- C. No verbal agreements or conversations prior to execution of this Contract or requested amendment shall affect or modify any of the terms or conditions of this Contract unless reduced to writing according to the applicable provisions of this Contract.

27. Choice of Law

The parties have executed and delivered this Contract in the County of Solano, State of California. The laws of the State of California shall govern the validity, enforceability or interpretation of this Contract. Solano County shall be the venue for any action or proceeding in law or equity that may be brought in connection with this Contract.

28. Health Insurance Portability and Accountability Act

Contractor represents that it is knowledgeable of the Health Insurance Portability and Accountability Act of 1996 ("HIPAA") and its implementing regulations issued by the U.S. Department of Health and Human Services (45 C.F.R. parts 160-64) regarding the

protection of health information that may be obtained, created, or exchanged as a result of this Contract and shall abide by and implement its statutory requirements, if applicable.

29. Waiver

Any failure of a party to assert any right under this Contract shall not constitute a waiver or a termination of that right, under this Contract or any of its provisions.

30. Conflicts in the Contract Documents

The Contract documents are intended to be complementary and interpreted in harmony so as to avoid conflict. In the event of conflict in the Contract documents, the parties agree that the document providing the highest quality and level of service to the WDB-SC shall supersede any inconsistent term in these documents.

31. Faith Based Organizations

- A. Contractor agrees and acknowledges that WDB-SC may make funds available for programs or services affiliated with religious organizations under the following conditions: (a) the funds are made available on an equal basis as for programs or services affiliated with non-religious organizations; (b) the program funded does not support religious activities; (c) the organization complies with the terms and conditions of this Contract.
- B. Contractor agrees and acknowledges that WDB-SC may not make funds available for programs or services affiliated with a religious organization that (a) has denied or continues to deny access to services on the basis of race, color, religion, ancestry, national origin, sex, citizenship, or known disability; (b) will use the funds for a religious purpose, (c) will use funds for a program or service that subject its participants to religious education.
- C. Contractor agrees and acknowledges that all recipients of funding from WDB-SC must (a) comply with all legal requirements and restrictions imposed upon government funded activities set forth in Article IX, section 8 and Article XVI section 5 of the California Constitution and in the First Amendment to the United States Constitution; and (b) segregate such funding from all funding used for religious purposes.

32. Pricing

Should Contractor, at any time during the term of this Contract, provide the same goods or services under similar quantity, terms and conditions to one or more counties in the State of California at prices below those set forth in this Contract, then the parties agree to amend this Contract so that such lower prices shall be extended immediately to WDB-SC for all future services.

33. Use of Provisions, Terms, Conditions and Pricing by Other Public Agencies

Contractor and WDB-SC agree that the terms of this Contract may be extended to any other public agency located in the State of California, as provided for in this section. Another public agency wishing to use the provisions, terms, and pricing of this Contract to contract for equipment and services comparable to that described in this Contract shall be responsible for entering into its own contract with Contractor, as well as providing for its own payment provisions, making all payments, and obtaining any certificates of insurance and bonds that may be required. WDB-SC is not responsible for providing to any other public agency any documentation relating this Contract or its

implementation. Any public agency that uses provisions, terms, or pricing of this Contract shall be virtue of doing so be deemed to indemnify and hold harmless WDB-SC from all claims, demands, or causes of actions of every kind arising directly or indirectly with the use of this Contract. WDB-SC makes no guarantee of usage by other users of this contract nor shall the WDB-SC incur any financial responsibility in connection with any contracts entered into by another public agency. Such other public agency shall accept sole responsibility for placing orders and making payments to Contractor.

34. Disbarment or Suspension of Contractor

- A. Contractor represents that its officers, directors and employees (i) are not currently excluded, debarred or otherwise ineligible to participate in the federal health programs as defined in 42 WSC § 1320a-7b(f) (the "Federal Healthcare Programs") or any state healthcare programs; (ii) have not been convicted of a criminal offense related to the provision of healthcare items or services but or previously excluded, debarred, or otherwise declared ineligible to participate in the Federal Healthcare Programs or any state healthcare programs and (iii) are not, to the best of its knowledge, under investigation or otherwise aware of any circumstances which may result in Contractor being excluded for participation in Federal healthcare programs or any state healthcare programs.
- B.. This representation and warranty shall be an ongoing representation and warranty during the term of this Contract and Contractor must immediately notify the WDB-SC of any change in the status of the representation and warranty set forth in this section.
- C. If services pursuant to this Contract involve healthcare programs, Contractor agrees to provide certification of non-suspension with submission of each invoice. Failure to submit certification with invoices will result in a delay in WDB-SC processing of Contractor's payment.

35. Execution of Counterparts

This contract may be executed in two (2) or more counterparts, each of which together shall be deemed an original, but all of which together shall constitute one and the same instrument, it being understood that all parties need not sign the same counterpart. In the event that any signature is delivered by facsimile or electronic transmission (e.g., by email delivery of a ".pdf" format data file), such signature shall create a valid and binding obligation of the party executing (or on whose behalf such signature is executed) with the same force and effect as if such facsimile or electronic signature pay were an original signature.

36. Entire Contract

This Contract, including any exhibits referenced, constitutes the entire agreement between the parties and there are no inducements, promises, terms, conditions or obligations made or entered into by WDB-SC or Contractor other than those contained in it.

EXHIBIT D SPECIAL TERMS AND CONDITIONS

1. Contract Extension

Notwithstanding Section 2 of the Standard Contract, and unless terminated by either party prior to September 30, 2017, this Agreement shall be automatically extended from October 1, 2017 through September 30, 2019 to allow for continuation of services and sufficient time to complete novation or renewal contract.

2. Termination

Notwithstanding Section 4 in Exhibit C, this Contract may be terminated by Workforce Development Board of Solano County (WDB-SC) or Contractor, at any time, with good cause, upon 30 days written notice from one to the other.

3. Additional Insurance

- Errors and Omissions insurance against loss due to negligent acts, errors and/or omissions, in an amount no less than one million dollars (\$1,000,000.) combined single limit per claim an in aggregate. The policy shall be written on an occurrence form or shall remain in full force and effect for no less than 3 years following the completion of work under this Contract.
- Professional malpractice insurance of all activities of Contractor (and its subcontractors) arising out of or in connection with this Contract in an amount no less than one million dollars (\$1,000,000.) combined single limit for each occurrence. The policy shall be written on an occurrence form or shall remain in full force and effect for no less than 3 years following the completion of work under this Contract.

4. Special Responsibilities of Contractor

- Submit verification of non-profit status, if a requirement for the award of this Contract;
- Provide an audit report, including a management letter to the WDB-SC annually;
- Conduct an audit, at Contractor's expense, according to the requirements of OMB Circular A-133, which identifies all funds granted, received, disbursed and expended and provide the audit to WDB-SC within 30 days of Completion;
- Provide an unaudited statement of revenue and expenditures to WDB-SC within 30 days of completion of the project if funds awarded to Contractor are \$100,000 or less.

5. <u>Confidentiality of Mental Health Records (if applicable)</u>

Contractor warrants that Contractor is knowledgeable of Welfare and Institutions Code section 5328 respecting confidentiality of records. WDB-SC and Contractor shall maintain the confidentiality of any information regarding clients (or families) receiving Contractor's services. Contractor may obtain such information from application forms, interviews, tests or reports from public agencies, counselors or any other source. Without the client's written permission, Contractor shall divulge such information only as

necessary for purposes related to the performance or evaluation of services provided pursuant to this Contract, and then only to those persons having responsibilities under this Contract, including those furnishing services under Contractor through subcontractors.

6. <u>Confidential Records (if applicable)</u>

Contractor acknowledges that any information generated, received or disseminated pursuant to its performance under this Contract is confidential and shall not be disclosed in any manner unless authorized by law. Further, Contractor warrants that Contractor is knowledgeable of Welfare and Institutions Code sections applicable to the subject of this Contract, particularly, sections 10850 and 11478.1 and will abide by its requirements.
