## **RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING LISA R. ROSE, ACCOUNTING CLERK III, UPON HER RETIREMENT FROM THE DEPARTMENT OF HEALTH & SOCIAL SERVICES WELFARE ADMINISTRATION FISCAL ISSUANCE UNIT WITH OVER 33 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY**

**WHEREAS**, Lisa R. Rose began her career on May 1984 in the Health & Social Services Department Records Division as a Typist Clerk II where she prepared cases and updated customers' records for eligibility workers; and

**WHEREAS**, In September 1986, Ms. Rose joined the Assessor's Office in the Business Property Division where she assisted customers with their business, boats or vehicle assessments and in November, became a Document Clerk; and

**WHEREAS**, In 1988, Ms. Rose changed career paths, becoming a Legal Procedures Clerk in the Vallejo Benicia Municipal Courts, Traffic Division, responsible for taking payments for traffic violations; and

**WHEREAS**, In 1991, Ms. Rose was qualified for the Fiscal Clerk position and after a year, achieved that position and was responsible for summoning prospective jurors for upcoming trials and interviewed clients requesting financial assistance; and

**WHEREAS**, A few years later Ms. Rose transferred to the Public Health Division in the Public Health Laboratory where she was responsible for preparing billing statements for local hospitals and county offices. In April 1999, her job title was reclassified to Accounting Clerk III; and

**WHEREAS**, In 2000, Ms. Rose joined Health and Social Services, Electronic Benefits Transfer (EBT)/Fiscal Issuance Unit, responsible for processing EBT cards, immediate need benefits and homeless assistance checks; and

**WHEREAS**, Ms. Rose's hard work has supported the mission of Health & Social Services to safeguard the physical, emotional, and social well-being of the people of Solano County by assisting people who are living in poverty and are vulnerable.

**NOW, THEREFORE, BE IT RESOLVED**, that the Solano County Board of Supervisors hereby commends Lisa R. Rose for over 33 years of dedicated service to Solano County and wishes her well in her retirement and future endeavors.
