Enclosed please find the "Notice Calling for Nomination for the Office of Trustee of Reclamation District No. 2129" and "Notice of Election of Reclamation District No. 2129." Reclamation districts are required to hold elections on the first Tuesday following the first Monday in November in odd number years. The "Notice Calling for Nominations...." was published on September 6st 2017, which is not more than 75 days prior to the required election date nor less than 7 days prior to the 54th day before the election date. No nominations were received prior to 5:00 p.m. on the 54th day prior to the election. If no nominations are received, the Board of Supervisors may appoint any qualified person as trustee.

The "Notice of Election...." was published on October 1nd, 2017, which was at least 30 days prior to the previously set election date. This notice stated that no election will be held and that the Solano County Board of Supervisors will appoint the trustees.


