

 Department of Water Resources and State Water Resources Control Board supportive of collaborative efforts




## Flood: Yolo Bypass & Cache Slough Continued

## **Delta Updates**

#### CA WaterFix (Tunnels)

- State Water Resources Control Board Hearing on change in the Point of Diversion in the Delta (WaterFix) ongoing
- Metropolitan Water District voted to fund larger share and to support two tunnels
- Supplemental Environmental Document from DWR and Bureau of Reclamation to be released in June/July 2018
- Two additional litigation cases:
