Minute Order and Executed Resolution

City of Suisun City Accounting Services Manager Elizabeth Luna provided an overview of the item.

Board Member Wilkerson commented on page 2 of the item regarding the formula restrictions that the Supplemental Educational Revenue Augmentation Fund (SERAF) would be subjected to.

Ms. Luna noted that the city used a ten year payment term.

Board Member Wilkerson asked under what terms the Department of Finance (DOF) could reduce the annual repayment.

Ms. Luna advised that the DOF was the determining agency.

Deputy Auditor-Controller Rosemary Bettencourt advised that the formula was provided by the DOF and was based on the FY2012/13 base amount of the residual balance that was received by the successor agency and was determined off of that amount minus what the agency got in the previous year and then divided by two. She advised that the amount was approximately \$1.5 - \$2 million for the FY2019/20 ROPS and noted that the agency was well below the amount requested.

Board Member Wilkerson noted that if there was a shortfall, the DOF would come back and reduce the amount required to be paid.

Ms. Bettencourt advised that an analysis was conducted by the Auditor-Controller every year after the ROPS was submitted and that it would inform the DOF if there was not enough.

Board Member Wilkerson asked what the rationale was for using the FY2012/13 time period.

Board Member Spering advised that this date was set in legislation.

Deputy County Counsel Dan Wolk concurred that the date was included in the legislation by the DOF.

Chairperson Sampayan asked if the payment could be increased if it was found that the payment was too low.

Ms. Bettencourt noted that this was correct.

Chairperson Sampayan commented on the calculation being found to be correct.

Ms. Bettencourt advised that the calculation was correct.

On motion of Board Member Spering, seconded by Board Member Welch, the Board adopted Resolution No. 2019 - 6 approving the City of Suisun City Successor Agency loan repayment schedule to the City of Suisun City Low and Moderate Income Housing Fund. So ordered by 7-0 vote.
