## **RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING TAMIE R. TVRDIK, CLERICAL OPERATIONS SUPERVISOR, UPON HER RETIREMENT FROM THE DEPARTMENT OF LIBRARY SERVICES WITH OVER 30 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY**

**WHEREAS**, Ms. Tvrdik is a sea of calm, maintaining her good humor and positive outlook through a myriad of changes, including learning how to successfully navigate the quirks of two very different library directors; and

**WHEREAS**, Ms. Tvrdik is the first person that new Library employees encounter, displaying genuine warmth and welcome to these new members of the Library family as she shepherds them through the interview and hiring process; and

**WHEREAS**, Ms. Tvrdik is greatly valued and will be missed by her friends, co-workers and colleagues in the Library community for her integrity, breadth of knowledge, and dedication to the highest ideals of Library culture.
