Additional Provisions, If any: Eliminate Section 3.4 Eliminate Section 4.2 Eliminate Section 4.3 Amend Section 5.1 to read client will not be responsible for transportation, housing, etc. Amend Section 6.0 to read "The client will be responsible for the finder's fee with LocumTenens.com providing written approval to hire provider directly. Payment will be negotiated between provider and client. The finder's fee for psychiatrist \$24,000 and PNP/PA will be \$20,000. Amend Section 6.4 to read client will not be responsible for the excess expense related to interviews. Amend Section 9.1 to read 'The term of this Client Agreement is for a period of two (2) years unless otherwise terminated as provided herein.' Eliminate Section 11.2 Amend Section 11.9 to read 'This Client Agreement shall be governed by the laws of the State of California.' Add Section 11.10 to read "The maximum amount County agrees to compensate LocumTenens.com shall not exceed \$3,095,000." Amend Fee Structure to exclude overtime rate charged as long as Provider, Client and LocumTenens.com agree that provider has chosen to work longer days during week by choice. Delete sentence in Section 11.2 that reads "If LocumTenens.com prevails, Client agrees to pay for reasonable expenses, including attorneys' fees."

The provisions hereof shall control over any inconsistent provisions contained in the Client Agreement (to the extent of the Inconsistency). The effective date of this Addendum is July 1st 2019 for rates and December 1st for dollar increase.
