## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING LYN FULLER, SOCIAL SERVICES SUPERVISOR UPON HER RETIREMENT FROM THE HEALTH AND SOCIAL SERVICES DEPARTMENT, PUBLIC HEALTH DIVISION, OLDER & DISABLED ADULT SERVICES BUREAU WITH MORE THAN 20 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY

WHEREAS, Lyn Fuller began her career on January 4, 1999 with Solano County Health and Social Services Department as a Senior Social Services Worker providing In-Home Supportive Services eligibility assessments and investigations for allegations of older and dependent adult abuse; and

WHEREAS, Ms. Fuller on March 21, 1999, she became a charter member of the newly formed Older & Disabled Adult Services Division of Health & Social Services, a new division providing integrated senior services in which she continued conducting In-Home Supportive Services eligibility assessments, Adult Protective Services abuse investigations and risk mitigation through the provision of social service interventions; and

**WHEREAS**, Ms. Fuller developed close working relations with County Counsel and the Public Guardian divisions developing a strong skill set for conducting investigations into the need for probate conservatorships, submitting petition referrals for Probate conservatorships and providing case management to clients; and

**WHEREAS,** Ms. Fuller in November 2000 was reclassified to a Social Worker III where she was responsible for difficult casework dealing with highly complex individual and family problems of the In-Home Supportive Services program and Adult Protective Services programs; and

**WHEREAS,** Ms. Fuller in February 2006, began a 'Working out of Class' as a Social Services Supervisor in the Public Guardian program where she completed a three-month assignment responsible program management. Once a new supervisor was hired, she remained with the Public Guardian program conducting conservatorship investigations; and

**WHEREAS,** Ms. Fuller in August 2007, through competitive promotion, became a Social Services Supervisor in the Older & Disabled Adults Division where she was responsible for the supervision of staff and casework of the In-Home Supportive Services program and Adult Protective Services program; and

**WHEREAS,** Ms. Fuller was the trainer for new social worker staff in both the In-Home Supportive Services program and Adult Protective Services program all the while building relationships with community partner agencies; and

**WHEREAS,** Ms. Fuller in 2016, the Older & Disabled Adult Services Division became a Bureau of the Public Health Division of the Health & Social Services Department she continued in her role as a Social Services Supervisor; and

**WHEREAS,** Ms. Fuller worked diligently to the 'how can I help' mission of Older & Disabled Adults Services clients to have them remain safe in their own homes and has displayed a commitment to the Older & Disabled Adult Services Bureau; and

**WHEREAS**, Ms. Fuller will officially retire effective December 30, 2019 after providing more than 20 years of service in a professional, compassionate and responsible manner.

**NOW, THEREFORE BE IT RESOLVED,** that the Solano County Board of Supervisors hereby recognizes Lyn Fuller for more than 20 years of outstanding and dedicated service to the residents of Solano County, and wishes her success in future endeavors and a long, happy, and well-deserved retirement.
