NOTICE OF PUBLIC HEARING

(Board of Supervisors)

The County of Solano does not discriminate against persons with disabilities and is an accessible facility. NOTICE IS GIVEN that the Solano County Board of Supervisors will hold a public hearing to consider a 10 month and 15 day extension of an urgency interim ordinance imposing a temporary moratorium on the cultivation or processing of industrial hemp within the unincorporated areas of the County of Solano.

Summary of proposed ordinance: The ordinance prohibits, as a land use matter, the cultivation or processing of industrial hemp within the unincorporated area of the County of Solano, beginning January 1, 2020. This prohibition supersedes any registration issued by the Solano County Agricultural Commissioner for the cultivation of industrial hemp.

The Board of Supervisors will also consider finding that the extension of the interim urgency ordinance is exempt from further environmental review under the General Rule Exemption of Section 15061(b)(3) of Title 14 of the California Code of Regulations because there is no possibility that the project may have a significant effect on the environment.

Any person wishing to comment on the proposed ordinance and/or review the information contained within the project file may do so at the Solano County Department of Resource Management, Planning Division, County Administration Center, 675 Texas Street, Suite 5500, Fairfield. In addition, a copy of the proposed ordinance and related staff report will be available by 5:00 p.m. the Friday prior to the meeting at www.solanocounty.com under Quick Clicks, Board Meetings.

If you challenge the proposed consideration in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.

The hearing will be held in the Board of Supervisors' Chambers, County Administration Center, 1st Floor, 675 Texas Street, Fairfield on Tuesday, December 10, 2019 at 9:00 a.m. or as soon thereafter as the matter may be heard. Interested persons may appear and be heard at that time.
