## RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS HONORING NANCY J. WILSON, DEPUTY DIRECTOR OF LIBRARY SERVICES, UPON HER RETIREMENT FROM THE DEPARTMENT OF LIBRARY SERVICES WITH OVER 25 YEARS OF DEDICATED SERVICE TO SOLANO COUNTY

**WHEREAS**, Nancy J. Wilson has been a valued member of the Solano County Library staff for twenty five years, two months and two days, beginning her tenure as Librarian at the Suisun City Library branch on October 26, 1994; and

**WHEREAS**, Ms. Wilson soon thereafter assumed the position of cataloging librarian within the Library's Technical Services division for the next 16 years until she was promoted to Supervising Librarian of the division on March 6, 2011; and

**WHEREAS**, Ms. Wilson's diligence to detail served the Library and community well as she precisely assigned call numbers to library materials, prepared the annual materials budget, supervised the acquisition and processing of materials, served as chair of the SPLASH (Solano Partner Libraries & St. Helena consortium) Operations Group, oversaw interlibrary loan transactions and transitions, and tested, managed and implemented upgrades to the consortium's integrated library system; and

**WHEREAS**, Ms. Wilson was instrumental in developing the Library's inaugural staff development and training program in 2005 and represented the Library and County on a statewide and national level by her participation in the California Library Association, American Library Association, and The Library Corporation Users Group; and

**WHEREAS**, Ms. Wilson served in her supervisory role until her promotion to Deputy Director of Library Services on April 10, 2016 where she managed the Library's transition to radio-frequency identification (RFID) and automated materials handling processes, the inclusion of digital and streaming resources to the Library's collections, and managed circulation services system-wide; and

**WHEREAS**, Ms. Wilson is greatly valued and respected and will be missed by her friends, co-workers and colleagues in the Library community for her affable personality, integrity, breadth of knowledge, sense of humor, and dedication to the highest ideals of Library culture.

**NOW, THEREFORE BE IT RESOLVED**, that the Solano County Board of Supervisors hereby recognizes Nancy J. Wilson for her many years of outstanding and dedicated service to the people of Solano County and joins her legion of friends and colleagues at the Solano County Library in wishing her a long, healthy, and happy retirement.
