Technical Correction to Resolution Amending (Minimum) Wage

On December 10, 2019, the Board of Supervisors adopted a resolution amending the wage to six unrepresented classification due to the pending increase in the California minimum wage.

The classification of contract Employee – Professional shows a maximum wage of \$145 per hour and the classification of Contract Employee – Technical shows a maximum wage of \$100 per hour.

The maximum wage of each of these two classifications should have been listed at \$150 and \$105 per hour as the Board increased the maximum rate with Resolution 2019-6 (January 8, 2019). Consistent with delegated authority provided to the Director of Human Resources, I am correcting the resolution. The amended resolution is attached.
