FIRST AMENDMENT TO STANDARD CONTRACT BETWEEN COUNTY OF SOLANO AND HEALTHY COOKING WITH KIDS, INC., DBA INNOVATIVE HEALTH SOLUTIONS

This First Amendment is made on March 12, 2020, between the COUNTY OF SOLANO, a political subdivision of the State of California ("County") and HEALTHY COOKING WITH KIDS, INC., DBA INNOVATIVE HEALTH SOLUTIONS ("Contractor").

1. Recitals

- B. Scope of Work
 - i. Section 5 (Location of Services) of Exhibit A is amended to include American Canyon Senior Center and Fairfield Senior Center.
 - ii. Section 6 (Units of Service Requirements) of Exhibit A is deleted in its entirety and replaced with:
 - A. Health Promotion Contracted Services:
 - 1) Health Promotion: 580 Contacts
 - 2) Unduplicated Clients: 60
- C. Budget

Exhibits B-1 and B-2 are deleted in their entirety and replaced with the Funding Summary and Budget Detail attached to and incorporated by this reference as Exhibits B-1-1 and B-2-1, respectively.

3. Effectiveness of Contract

Except as set forth in this First Amendment, all other terms and conditions specified in the Contract remain in full force and effect.
