


Background

- In FY2018/19, Board conducted a Human Services Needs Assessment to assist with a framework and process to:
 - 1. Identify greatest human service needs and effective strategies
 - 2. Allocate funding to meet those needs
 - 3. Have a structure for monitoring progress
 - 4. Measure impact
- Information sources
 - Review of community data
 - 43 key informant interviews
 - Almost 900 responses to community survey

Annual Grants

- Issued Annual Request for Proposal (RFP) in January 2020 to address any one of the top 6 needs
 - 1. Mental Health
 - 2. Housing
 - 3. Homelessness
 - 4. Early Education
 - 5. Youth Development
 - 6. Safe and Stable environments for Children
- Funds up to \$50,000 per proposal
- Conducted bidders conference with
 78 individuals representing 84 agencies

Priority	Mental Health
Amount	\$50,000
Purpose	To increase access to Solano County's mental health system of care through the hiring of a case manager to support patients with mental health concerns.



#2 - Dixon Unified School District

Priority	Mental Health
Amount	\$50,000
Purpose	To improve supports for the social, emotional, behavioral, health, and mental health needs of students and integrate those supports with their academic instruction by staffing their new Wellness Center.



#3 – On the Move

Priority	Youth Development
Amount	\$49,500
Purpose	To serve 400 system-involved youth transition into healthy adulthood.



#4 – Fairfield Police Activities League

Priority	Youth Development
Amount	\$50,000
Purpose	To implement the Earn and Learn Internship program to provide low income or disconnected/underserved teens with a quality paid internship experience to position the youth on a career or college path.



#5 - Community Medical Centers

Priority	Mental Health
Amount	\$50,000
Purpose	To enhance and increase behavioral health services and screenings for low-income residents.



#6 - Napa/Solano SANE/SART - Trauma Recovery Ctr

Priority	Homelessness
Amount	\$49,754
Purpose	To provide expanded emergency housing support and temporary shelter services for marginalized crime victim populations.



#7 – Fairfield Suisun USD Family Resource Ctr

Priority	Safe and Stable Environments for Children
Amount	\$49,684
Purpose	To provide intensive case management for at-risk families, including supporting their basic needs.
