Solano County Emergency Services Manager Don Ryan provided an overview of damage and current activities to assess and analyze the financial impacts caused by the recent fire emergency. He then provided information on the efforts by local governments and partners during the emergency.

Supervisor Brown commented on fire damage in Gordon Valley and concerns about upcoming rain that could cause issues.

Mr. Ryan noted that he had toured the area and advised that there would likely be minimal impacts on the County. He advised that CalFIRE had brought out geologists and hydrologists to survey the areas and that they were actively working to take care of the damaged areas.

County Administrator Birgitta Corsello advised that the staff and juvenile

facility evacuees from Sonoma County had returned to their county and noted that they had sent a letter to Solano County in thanks for the support and services provided to the evacuees.

On motion of Supervisor Hannigan, seconded by Supervisor Spering, the Board adopted Proclamation No. 2017-239 Terminating Local Emergency. So ordered by 5-0 vote. (see Resolution Book)

Legislative, Intergovernmental and Public Affairs Officer Michelle Heppner introduced the item.

Supervisor Brown commented on the County's proposed federal legislative platform regarding support for funding for the Children's Health Insurance Program.

Ms. Heppner noted that the platform was a broad overview and that this subject would fall under the County's top priority area concerning children.

In response to comments from Supervisor Brown, Ms. Heppner noted that flood response could be added to the federal platform and that rail and rail car safety would cover all products carried in the rail cars.

In response to comments from Chair Vasquez, Ms. Heppner advised that the County's platform had received many kudos based on its format and broadness to cover topics.

Supervisor Brown requested that homeless individuals and families be added under the state platform regarding support for housing opportunities for the low income.

Chair Vasquez noted that the County would encourage and support cities to provide this kind of housing and advised that the County had very little areas for this type of housing.

Ms. Heppner suggested adding language regarding support of cities' efforts on the matter.

Supervisor Hannigan commented on the inclusion of the word "homeless"

and suggested that the language state "...families, such as permanent and transitional rental assistant programs" under Item 2 of the Housing, Community and Economic Development, and Workforce Investment policy area.

Chair Vasquez commented on the County's zoning, noting that it was mainly the cities that had areas for affordable housing.

Supervisor Spering suggested stating that the County would support or encourage affordable housing or support legislation that would promote affordable housing shelters for homeless, etc.

Ms. Heppner noted that this language would be added.

State Advocate Karen Lange provided an overview of legislative activities that had taken place at the state capitol. She then provided information on legislation of interest to the County regarding child care funding, housing shortage and affordability, document recording fees, a housing bond package, a water and parks bond package, the Cap and Trade program, transportation, impacts on housing from the recent fires, the Twin Tunnels project, single payer health plans, health care coverage impacts by federal activities and IHSS funding.

Supervisor Brown asked if there had been any discussion regarding keeping housing construction material prices from going too high.

Ms. Lange noted that the Attorney General had released warnings about price gauging and advised that Sonoma County was working on ordinances to address options for their residents to live while rebuilding their homes.

Ms. Heppner provided information on federal activities of interest to the County.

On motion of Supervisor Hannigan, seconded by Supervisor Spering, the Board approved Solano County's 2018 State Legislative Platform and Solano County's 2018 Federal Legislative Platform as amended. So ordered by 5-0 vote.

Supervisor Spering commented on redevelopment and suggested holding a workshop in the future to determine a position on redevelopment if it should come back. He advised that redevelopment benefited everyone.

Chair Vasquez also commented on redevelopment.
