*D) Father Robert Fuentes, Director of Faith in Action, commented on a recent news article concerning the potential closure of the Area Agency on Aging Serving Napa & Solano Counties (AAOA) and the need for assistance to the agency.*

*Chair Vasquez noted that activities and discussions were taking place concerning the issues surrounding the AAOA.*

*Supervisor Spering commented on current activities taking place and advised that there was a meeting later in the day between both counties, the state and the AAOA to discuss the matter.*

*Mr. Fuentes noted that he has sent a letter to the AAOA asking that the providers be involved in any potential solutions moving forward.*

*Auditor-Controller Simona Padilla-Scholtens noted that there was no error in the allocation for the lighting district and advised that the only way a reallocation of sharing ratios between all the lighting districts could happen would be if one of the agencies within one of the districts was willing to give up its allocated tax money.*

*In response to a question from Chair Vasquez, Mr. Bunting provided information on Item 5 regarding litigation expenses, noting that there were a number of matters pending and that the amount requested was an estimate to cover legal expenses.*

*Principal Planner Matt Walsh provided information on Item 9 noting that it was an update to the Administrative Plan for the Solano County Housing Authority which allowed for streamlining in the recertification process for current voucher holders. He noted that the City of Vacaville was contracted to operate the Solano County Housing Authority on behalf of the County.*

*Supervisor Hannigan noted that the numbers in the plan did not include the new Dixon housing for veterans that Mr. Tipton had commented on.*
