RESOLUTION OF THE SOLANO COUNTY BOARD OF SUPERVISORS APPROVING TENTATIVE AGREEMENT WITH THE CHAUFFEURS, TEAMSTERS AND HELPERS LOCAL 150, UNIT #1 ATTORNEYS, APPROVING SIDE LETTER AGREEMENTS CONCERNING BASE WAGE INCREASE REOPENER AND PAY PARITY, AND DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATIVE OFFICER OR DIRECTOR OF HUMAN RESOURCES TO EXECUTE THE SUCCESSOR MEMORANDUM OF UNDERSTANDING

WHEREAS, the County of Solano (“County”) and the Chauffeurs, Teamsters and Helpers Local 150 (“Unit #1”) representing Unit #1 Attorneys, are parties to a Memorandum of Understanding (“MOU”) governing wages, hours, and other terms and conditions of employment; and

WHEREAS, the representatives for the County and Unit #1 have negotiated in good faith and reached a Tentative Agreement for a successor MOU with a term beginning June 2, 2026, and expiring September 30, 2028; and

WHEREAS, the Tentative Agreement has been ratified by the membership of Unit #1; and

WHEREAS, the parties are in the process of preparing the written successor MOU consistent with the ratified Tentative Agreement; and

WHEREAS, it is in the best interest of the County to accept the Tentative Agreement and authorize execution of the successor MOU once finalized, provided it is consistent with the agreement approved by the Board;

NOW, THEREFORE BE IT RESOLVED, that the Solano County Board of Supervisors hereby:

1. Accepts the Tentative Agreement between the representatives of the County and the Chauffeurs, Teamsters and Helpers Local 150, Unit #1 Attorneys, as ratified by the bargaining unit membership, for the term June 2, 2026, through September 30, 2028; and
2. Approves the Side Letter Agreements to the Memorandum of Understanding to be entered into with the Chauffeurs, Teamsters and Helpers Local 150, Unit #1 Attorneys, concerning Base Wage Increase Re-opener and Pay Parity; and
3. Delegates authority to the County Administrative Officer or Director of Human Resources to execute the successor Memorandum of Understanding and the Side Letters and to make technical, non-substantive adjustments, provided that the final document is consistent with the Tentative Agreement approved by this Board; and
4. Authorizes the implementation of the terms of the Tentative Agreement in accordance with applicable County policies.
