NOTICE OF PUBLIC HEARING

(Board of Supervisors)

NOTICE IS HEREBY GIVEN that the Solano County Board of Supervisors will hold a PUBLIC HEARING to consider an appeal by Matthew Flaherty of the Solano County Zoning Administrator's June 19, 2025 approval of Minor Use Permit Application No.: MU-23-08 of Mike and Rhonda Petrillo to establish a Special Events Facility (Small/Medium). The project has been determined not to have a significant effect on the environment and is categorically exempt from the California Environmental Quality Act pursuant to Section 15303 Class 3 - New Construction or Conversion of Small Structures & Section 15304 Class 4, Minor Alterations to Land. The property is located three (3) miles southwest of the City of Winters in the Exclusive Agriculture 20-acre minimum (A-20) zoning district at 3695 Vickrey Lane, APN 0101-090-550. (Project Planner: Travis Kroger, 707-784-6765)

The hearing will be held in the Board of Supervisors' Chambers, County Administration Center, 1st Floor, 675 Texas Street, Fairfield, California on **Tuesday, September 9, 2025, at 2:00 pm** or as soon thereafter as the matter may be heard. If you challenge the proposed consideration in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors at, or prior to, the public hearing.
