REGULAR CALENDAR

Principal Management Analyst Matthew Davis introduced the item.

Federal Legislative Advocates Rachel MacKey and Hasan Sarsour provided an update on current legislation of interest to the County including FY2026/27 earmarks, Surface Transportation Reauthorization, and the House Farm bill. Ms. Mackey provided an overview of the recent NACo Legislative Conference in Washington, D.C., attended by Supervisor Williams, and County staff. Ms. Mackey and Mr. Sarsour both commented on the benefits of the conference noting it provided an opportunity for County leaders to exchange ideas with peers nationwide and engage with federal officials on policy issues affecting counties. Ms. Mackey noted that meetings were held with Representatives Garamendi and Thompson and Senators Schiff and Padilla to advocate for Solano County's priorities and discuss community project funding earmarks. Supervisor Williams was commended for her advocacy. Ms. Mackey further stated follow-up with congressional offices is ongoing, particularly regarding

earmark requests, noting the submission dates are Friday, March 4, 2026, for both Congressman Thompson and Senator Schiff and the submission date for Congressman Garamendi is Monday, March 9, 2026.

In response to a question from Chair Brown regarding the reauthorization of the Older American's Act, Ms. Mackey stated that the reauthorization of the Older Americans Act has not advanced, although it nearly passed during the last Congress as part of a broader government funding package. Ms. Mackey further stated despite the lack of reauthorization, the programs continue to receive funding because they are discretionary, and they were largely funded in the early February government funding agreement.

In response to a question from Supervisor Williams regarding the Farm Bill, Mr. Sarsour explained that the House Agriculture Committee has begun consideration of the Farm Bill reauthorization, noting the last extension is through September 30, 2026. Mr. Sarsour further stated while many provisions of the Farm Bill have bipartisan support, the bill has become increasingly partisan due to disagreements over SNAP policy changes, as well as debates over issues such as pesticide regulation and hemp, noting that these political divisions may mean the bill will face delays.

In response to a question from Supervisor James regarding an update on affordable housing, Ms. Mackey stated the House recently passed the *Housing for the 21st Century Act*, aimed at reducing regulatory barriers and streamlining affordable housing development, while the Senate is considering a compromise bill that incorporates elements from both chambers' proposals. Ms. MacKey further stated the Senate measure has White House support but includes a provision that could penalize local governments through Community Development Block Grant funding if housing growth targets are not met, which has raised concerns among counties. Ms. Mackey noted there is progress toward a housing package, but the final outcome between the House and Senate remains uncertain.

In response to a question from Supervisor Mashburn regarding movement on maritime issues, Mr. Sarsour stated there are currently no new legislative developments related to maritime initiatives despite the maritime prosperity zone designation, noting however, the issue remains a priority for the White House and federal partners, with ongoing discussions about dredging near Mare Island and potential future funding sources, though nothing definitive has been announced.

State Legislative advocate Karen Lange provided an overview of the current California legislative session, noting that new rules limiting bill introductions reduced the total number of bills this year and that committees will soon begin hearings. Ms. Lange also highlighted several potential November ballot measures that could impact local governments, including proposals related to local tax limitations, voter ID requirements, and CEQA reform. Ms. Lange provided an update on the state budget outlook and emphasized major concerns for counties regarding the impacts of H.R. 1, which could

significantly increase county costs for health and social services without additional state funding. Ms. Lange provided an overview of several state legislative proposals relevant to counties, including a bill by Senator McNeerney to invest in Delta levee repairs and water infrastructure as an alternative to a large water tunnel project. Ms. Lange also noted other proposals involving a potential housing bond, wildfire prevention efforts, and clarification that Assemblywoman Wilson's vehicle-miles-traveled bill only extends a study rather than creating a new tax. Additionally, she mentioned ongoing legislative efforts related to housing and homelessness funding, energy costs, and broader affordability issues being debated in Sacramento.

In response to a question from Chair Brown regarding Assembly Bill 1421 (Wilson) Ms. Lange explained that the bill extends the timeline for an existing state study examining alternatives to declining gas tax revenue, particularly in light of increased electric vehicle adoption. Ms. Lange noted the study focuses on identifying long-term transportation funding solutions that are fair and do not disproportionately impact those who commute long distances.

In response to a question from Supervisor Mashburn regarding proposed legislation by Assemblymember Wiener that could allow municipalities to use eminent domain to acquire PG&E infrastructure and form their own utilities, Ms. Lange stated Senator Wiener introduced SB 875 to streamline the process for local agencies seeking to municipalize electric utilities, which has historically been slowed by regulatory and legal challenges, particularly from PG&E. Ms. Lange further stated while the senator is strongly advocating for the bill, its passage may be difficult given the significant opposition and complexity involved.

Supervisor Mashburn expressed interest in learning whether county ownership of the Dixon substation could provide local control of electricity transmission and help address energy issues in the county.

In response to a question from Supervisor James regarding whether housing funding allocations disadvantage mid-size counties that may struggle to compete with larger jurisdictions and about potential administrative requirements, matching funds, or set-aside funding for counties that have received fewer housing dollars, Ms. Lange stated funding is typically distributed through existing state housing program funding pools rather than by county allocation, noting she would provide additional details on the proposed funding breakdown following the meeting.

In response to a question from Supervisor James regarding the Delta Levy Subvention Process, Ms. Lange stated the proposed \$150 million for Delta levees would be administered by the Delta Conservancy, noting this is a new approach intended to prioritize multi-benefit projects, and that funding would primarily be competed for by reclamation districts within the Delta's five counties. Assistant Director of Resource Management Misty Kaltreider stated Solano County and regional partners have previously identified priority levee projects and continue working with regional reclamation districts to advance

improvements that support flood protection, agriculture, and habitat restoration through multi-benefit projects.

Chair Brown invited members of the public to address the Board on this matter. There was no public comment.

Principal Planner Narcisa Untal introduced the item and provided an overview of the recommended action regarding a proposed 3% inflationary rate adjustment for solid waste, recycling, and organics services in the unincorporated areas of Solano County. Ms. Untal further stated that the Board established garbage service boundaries in 2003 and designated four haulers to provide collection and related services, which are funded through customer rates and are mandatory for certain zoning districts. Ms. Untal noted that the previous 10-year service agreement included a fixed 3% annual adjustment, followed by a one-year extension with no increase while negotiations for a longer-term agreement continued. Ms. Untal further stated the proposed adjustment would result in an estimated residential increase of \$0.82 to \$1.19 per month and \$2.05 to \$5.19 per month for commercial customers, depending on service levels Ms. Untal outlined the Proposition 218 noticing and protest process and recommended that the Board conduct the public hearing, tabulate written protests, and adopt the resolution approving the rate adjustment if no majority protest is received.

Chair Brown opened and closed the public hearing with no comments from the public.

Chair Brown requested the Chief Deputy Clerk of the Board report the total number of written protests received prior to the closing of the public hearing.

Chief Deputy Clerk Alicia Draves stated the total number of affected parcels is 5,818, noting that a majority protest would require at least 2,910 valid written protests. Ms. Draves further stated the Clerk's office received a total of 20 written protests prior to the close of the public hearing.

In response to a question from Supervisor Mashburn regarding the extended

time frame for the garbage contracts, Ms. Untal stated that administration of the garbage service contracts was transferred from the Department of General Services to the Department of Resource Management in May 2025, noting since then, the department has been conducting a detailed review of services and programs and preparing for upcoming legislative changes to incorporate into a new long-term agreement.

Supervisor Mashburn stated he would like staff to review the possibility of consolidation of the services into one organization, noting there could be cost savings. Supervisor Mashburn further requested County staff provide financial details related to the current franchise fees paid by the four organizations.

Chair Brown stated because the number of protests received is insufficient to constitute a majority protest, staff does not need to examine individual protests for validity. Chair Brown further stated all written protests received are deemed valid for purposes of this determination and accordingly, no majority protests exist.

On motion of Supervisor Williams, seconded by Supervisor Mashburn, the Board adopted Resolution No. 2026-37, approving a 3% inflationary rate adjustment for solid waste, organics, and recyclables services provided in unincorporated Solano County effective March 3, 2026. Receive a presentation on existing and future traffic conditions identified within the Suisun Valley Traffic Capacity Analysis study

Director of Resource Management James Bezek introduced the item.

Assistant Director of Resource Management Mathew Tuggle presented the results of a traffic capacity study for Suisun Valley, initiated in response to ongoing concerns about traffic impacts from development and agricultural activity in the area. Mr. Tuggle stated the County hired a consultant to conduct traffic counts, evaluate existing conditions, and analyze future traffic scenarios along the Suisun Valley Road corridor. Mr. Tuggle further stated the study found that current traffic conditions generally operate well within capacity during both typical and harvest seasons, with only intermittent delays caused by external factors such as freeway incidents. Mr. Tuggle noted however that future buildout over the next ten years could create congestion in the southern segments of the corridor, particularly near Solano Community College and Rockville Road, especially on Saturdays during peak visitor and harvest periods. Mr. Tuggle further stated the northern segments of the corridor are expected to continue operating at stable levels of service under projected growth conditions.

In response to a question from Supervisor Williams regarding potential future traffic issues along Rockville Road, particularly with increased visitors expected from the new Patwino Worrtila Kodoi Open Space Park, Mr. Tuggle

explained that the County has begun conceptual planning for possible improvements in that corridor. Mr. Tuggle noted that the County paused further planning until park usage increases so traffic and pedestrian activity can be monitored, after which improvements such as crossings or other traffic measures may be considered if needed.

A discussion and question and answer period was held regarding bicycle and pedestrian safety as traffic and recreational use continue to increase in the area, including concerns about cyclist visibility, lighting, and the growing use of high-speed scooters. Additional discussion addressed safety conditions on nearby roadways and bridges, including the pedestrian and bicycle crossing near the I-80 interchange by Solano Community College. Mr. Tuggle noted that scooter-related safety concerns are being monitored and indicated that Caltrans would likely be responsible for any improvements at the interchange.

In closing, Supervisor James requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Reverend David Lee McCarver.

B) Supervisor Williams reported participating in Read Across America at Rockville Elementary School, where she read to a fourth-grade class and donated a book to the school library. Supervisor Williams stated she also participated in a League of Women Voters panel discussion on the future of Solano County alongside regional elected officials and attended the National Association of Counties legislative conference in Washington, D.C., where she met with members of Congress to advocate for federal funding for several local projects and services. Supervisor Williams emphasized the importance of federal partnerships in supporting county programs and services. Supervisor Williams requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Frances Urbano.

C) Supervisor Mashburn requested that this meeting of the Solano County Board of Supervisors be adjourned in memory of Alexander Bosworth.
