On August 25, 2025, SRCD Board of Director Mr. Jim Waters unexpectantly passed away from a heart attack. This sad fact has left SRCD with a vacancy on the SRCD Board of Directors.

On September 23rd, 2025, SRCD posted a "Public Notice of Vacancy," which was provided to the Solano County Clerk's office for posting at the County Building. This "Notice of Vacancy" was also been posted on the SuisunRCD.org website and at the SRCD main office at 2544 Grizzly Island Road, Suisun City, CA 94585 (enclosed). The 10-day public notice period was completed on October 2nd, 2025.

As of today, SRCD has received one application to assume the remainder of Mr. Jim Waters term as SRCD Director. This application was received from the current SRCD Associate Director, Mr. John Eudy. Mr. Eudy is a landowner in the Suisun Marsh and has served as an SRCD Associate Director for the past 2½ years. Mr. Eudy's "Application for Directorship" and cover letter requesting appointment to the SRCD Board of Directors are enclosed.

Consistent with the Solano County Ordinance No. 1445 of July 28, 1992, SRCD requests County Counsel proceed with the process to have the Solano County Board of Supervisors consider the appointment of Mr. Eudy to the SRCD Board of Directors.

I am submitting my application for the position of Director for the Suisun Resource Conservation District (SRCD). SRCD Board Member, Mr. Jim Waters, recently passed away unexpectedly, leaving a vacancy on the SRCD Board of Directors.

Since January of 2023, I have served as a SRCD Associate Director, regularly attending monthly Board meetings and semi-annual landowner workshops. These past 2.5 years have provided me with a strong understanding of SRCD's unique responsibilities in the Suisun Marsh and how I can support the continued preservation of its wetland and wildlife resources. I hope to assume the remainder of Mr. Waters' term and respectfully submit my attached signed application for consideration.

In addition, I have been a landowner in the Suisun Marsh for over twenty-five years at Property #807 – Wheeler Island Duck Club, where I also served as the president of the duck club for thirteen years. As a member and co-owner of this property, I have worked extensively with SRCD on wetland habitat management activities, completing habitat enhancement projects, and securing annual environmental permits. These experiences have given me both an appreciation for and a deep understanding of the complexities of effectively conserving and managing the wetland resources of Suisun Marsh.

My professional background includes over forty-five years in the real estate investment business. I was a co-founder and Chief Investment Officer of Essex Property Trust, a publicly held real estate investment trust based in San Mateo, CA, until I retired in 2019. My education includes a B.S. in Finance from San Diego State University, as well as a postgraduate certification in Management Leadership from the University of Southern California. I believe this combination of professional expertise, leadership experience, and conservation work will enable me to make meaningful contributions to SRCD's ongoing efforts.
