Dear Clerk of the Board:

This office serves as general counsel to Reclamation District No. 2084 ("RD 2084"), and on its behalf, respectfully requests that the Solano County Board of Supervisors appoint Marshall Cook, Richard Harris, and Matt Gause to the office of Trustee of RD 2084 at the next regularly scheduled meeting of the Board of Supervisors.

The terms of three trustees expire on December 1, 2025. As such, RD 2084 published a Notice of General District Election and Call for Nominating Petitions. As the number of qualifying nomination petitions did not exceed the number of seats available, no election will be held pursuant to Water Code section 50740. Pursuant to Water Code section 50742, RD 2084 submits that the Solano County Board of Supervisors appoint the above-named individuals to the Office of Trustee of RD 2084 for four-year terms commencing December 1, 2025.
